BACKGROUND: The Noxious Weed Control Board consists of five voting members from five weed districts in the County, as defined in Clark County Code Title 7. Currently, seats from weed districts one (1) and five (5) are vacant. Following procedures outlined in RCW 17.10, Clark County recently requested applications to fill the vacancies in these two districts. Applications were received only for District Five.

The Noxious Weed Control Board recommends the Board of Commissioners appoint one new weed board member.

COMMUNITY OUTREACH: Clark County published a public notice announcing vacancies for the positions in The Columbian and Battle Ground Reflector during the weeks of January 2nd and 16th, 2013. A news release was also published on the Clark County website.

BUDGET AND POLICY IMPLICATIONS: Clark Count Noxious Weed Control Board members are volunteers. Meetings for the weed board will be held quarterly, and the staff time to coordinate these meetings is included in the approved 2013-2014 Environmental Services budget.

I. Call to Order, Roll Call, Approval of Minutes

Glenn called the meeting to order at 1:30 pm. The December 2012 minutes were reviewed.

II. Board Elections

Glenn opened nominations for Chair. Bill nominated Jerry, Kent seconded and Jerry accepted. Jerry nominated Bill for Vice Chair, Kent seconded, Bill accepted.

III. Public Hearing

Jerry opened the hearing at 1:45 pm. Seeing no one and hearing no comments the hearing was closed at 1:46 pm.

IV. 2013 Clark County Noxious Weed List

Glenn proposed to the Board to designate for control in Clark County bull thistle, Canada thistle, common tansy and fragrant waterlily from the class C list. Bull thistle and Canada thistle have historically been designated so the discussion centered on fragrant waterlily and common tansy. It was explained that the waterlily was present in the Ridgefield Wildlife Refuge and that we needed to be aware and to be able to require control, should it be discovered elsewhere. Common tansy is gaining a foothold in the Vancouver Lake lowlands and elsewhere in the County and designating it for control will require agencies to increase their control efforts. Policeman's helmet, currently a class B weed, is not in the County (that we know of yet) but is in surrounding Counties. It resembles a couple of our native plants in the area and could be overlooked. The change to a designated class B will increase awareness and require control if found. Bohemian, Himalayan and Japanese knotweed are currently listed as class B weeds. They are all present in the County and need to be designated as giant knotweed is currently a designated class B. After the discussion, Bill made a motion to adopt the 2013 Clark County Noxious Weed List as proposed, Kent second.

Motion passed 3-0.

V. Board Member Search

Glenn reported that there was only one application (District 5) that came in during the announcement period closing January 31, 2013.
