## What's the difference between a Neighborhood Association and a Homeowners Association?

A Neighborhood Association can be formed by residence within defined boundaries. It can include both homeowners and renters, but living within a certain development is not a requirement. Participation is voluntary. A Neighborhood Association is not regulatory and does not charge fees for membership or voting privileges.

A Homeowners Association (HOA) is set up by the developer of a subdivision to provide maintenance of common grounds, amenities and sometimes, a stormwater / drainage facility. Being a member of the HOA is not optional for homeowners. When people buy a home in a HOA, they understand they are subject to association fees and codes, covenants and restrictions (also referred to as CC&R's). The CC&R's are a civil contract that is attached to the deed of trust of their property.

#### What is the advantage to being a part of the Clark County Communities Neighborhood Outreach Program?

Neighbors nationwide have come together to shape the areas in which they live. By forming Neighborhood Associations, citizens work in partnership with their local governments to maintain or enhance the livability of their communities.

Clark County recognizes the value of neighborhood associations and working with residents to build community. Clark County has offered various services to neighborhoods since 1991, and established the Neighborhood Outreach Program in August 1996 to serve those living in unincorporated Clark County.
