- Clark County Public Health Solid Waste Operations
  - o Records Coordinator position filled by Amber McKnight

  - o Siting study RFP was cancelled, due to editing oversight
    - Will edit & re-release at a later date
  - o All but one ILA signed with local cities/town
  - Meeting with Regional System Steering Committee to discuss regional ownership of transfer stations, and timelines
  - Waste characterization study kick-off meeting today
- Clark County Public Health Solid Waste Education & Outreach
  - o Green Business has new Instagram account
  - o Held morning Blend at wastewater treatment plant yesterday
  - o Evergreen School District hosted green cleaning class in Spanish
  - o Green Neighbors website is undergoing significant overhaul
  - o Upcoming Food Waste Prevention week in April
- Clark County Public Health Solid Waste Enforcement
  - o Provided 2023 fourth quarter inspection updates
  - Burington Environmental (Clean Earth) received \$25,000 fine from Ecology, for violation of 10-day transfer, and inadequate employee training
    - ECY's opinion is that license should not be suspended/revoked/fined at this time
- City of Vancouver
  - o Cost of service change took effect January 1, 2024

  - o Signed ILA with Clark County Public Works to continue leaf coupon in the future

### III. Vape Disposal – J. Kimberly Walker-Norton & Jess Fischberg (\*00:30:03)

- Schools confiscating vape products in such high amounts that they are labeled as "Small Quantity Generators" (SQG); but do not have funding for proper disposal
- Schools are considered businesses, and are not eligible for HHW events
- Developing outreach materials for residential vape disposal, for distribution with vape venders
- Jess has looked into the feasibility of having the transfer stations include SQG collection, in addition to the HHW collection, but currently there is no timeline
  - o Some counties have this rolled into the cost of overall waste management

### IV. Solid Waste Management Plan Updates - Sean Henderson (Maul Foster Alongi) (\*00:58:33)

- Maul Foster Alongi continuing to update design of SWMP
- Have mocked up design layout
- Now focusing on hand-off process, for future updates
- Determined navigation and hierarchy of Table of Contents
- Ran troubleshooting for visual accessibility, including line length, font type and size, text color
- Layout is going quickly
  - o Expecting more content in March
- Will likely need to do another round of internal edits prior to completion
  - o Hope to be able to present new draft during May SWAC meeting
  - o Basing content on Ecology requirements
