#### **China No Longer Wants Your**

**Trash** (*The follow information was pulled from the Huff Post*)

On January 1st, 2018 China made good on its promise to close its borders to several types of imported waste. For more than 20 years China has been accepting enormous quantities of recyclable waste from nations worldwide.

China is now banning the import of 24 categories of solid waste, including waste plastic, unsorted scrap paper and waste textiles. This is their metaphorical "Green Fence" to contaminated recyclable waste.

Mere weeks after the China ban took effect, waste management facilities in several countries are groaning under the weight of their trash that no one seems to know what to do with. There is a scramble for alternative destinations or solutions for all the waste that is piling up.

Trash --- specifically imported trash --has been, for many years, big business for China. From the 1980's, China has eagerly accepted recyclable waste from countries worldwide to feed it's flourishing manufacturing sector and satisfy the demands of a growing population. The US currently exports about onethird of all of its recycling and almost 50 percent of that goes to China. In 2016, China imported a total of 45 million tons (or about \$18 billion worth) of scrap metal, waste (mixed) paper and plastic from countries across the globe.

#### Have you seen these weeds?



Japanese Knotweed is an invasive weed that is not native to Clark County. Since its inception in 2011, Clark Public Utilities' Eradication Nation has worked to stop its spread in Salmon Creek. Growing at a rate up to three inches per day this weed can grow up to 12 feet tall with stout bamboo-like hollow stems. It can push through building foundations and driveways, dominate native vegetation, and destroy fish and wildlife habitat. In March and April, knotweed shoots look like asparagus. Keep an eye out for any fast-growing bamboo-like plants!



Japanese Knotweed spreads vegetatively from its roots, stems, and rhizomes that break off and are carried to other locations. A piece the size of your fingernail discarded into yard waste or floating down a stream can generate an entirely new infestation.



Garlic mustard is another invasive plant that displaces native vegetation. Thousands of tiny seeds per plant make it easy for garlic mustard to spread over forest understory. Contact the Invasive Species Coordinator for more information on proper removal methods.

Join us today and learn to identify these invasive plants, report sightings, and participate as a volunteer! If you believe you have Japanese knotweed on your property, do not hesitate to contact Eradication Nation and schedule a site visit. With the help of a grant from the Centennial Clean Water Fund, we can provide **FREE control** of Japanese knotweed on properties in the Salmon Creek watershed.

Upcoming volunteer events are planned for March 24, May 12 and June 13.



## Tagger USK -WANTED

In case you have not noticed - graffiti tagger USK has been very prolific in the Hazel Dell community as well as along the I-5 and I-205 corridors.

Graffiti is done without permission and is considered vandalism. Gang graffiti is also threatening. In both cases, graffiti will attract more of the same if left in place. It creates a perception that the area where it is found is unsafe. For these reasons it is important to address it as soon as it is observed. Graffiti in any form is a blight to our community and projects a negative image. In addition if left unchecked it could lower property values in the long run.

#### **How should one report Graffiti?** *With suspect information*

If you see someone engaging in or have information about a suspect call 9-1-1 and state you are a Vancouver resident with a graffiti report.

#### Without suspect information

If graffiti is West of Andresen Road on Private Property – call the Vancouver Police Department West Precinct at: 360-487-7355 to make a report during regular business hours.

If graffiti is East of Andresen Road on Private Property – call the Vancouver Police Department East Precinct at: 360-487-7500 to make a report during regular business hours.

You can also make a police report for graffiti without suspect information anytime by calling the Vancouver Police Department during normal office hours (Monday-Friday, 8am-5pm) at (360) 487-7355.

If graffiti is located on Public Property – call the City of Vancouver Operations at: 360-696-8177 during regular business hours.

If the graffiti is located on State Highways or related overpasses – call the Washington State Department of Transportation at: 360-759-1300 during regular business hours.

If the graffiti is located on Electrical Boxes – call Clark Public Utility District at: 360-992-3000 during regular business hours.

If the graffiti is located on Bus Stops or Buses – call C-Tran at: 360-695-0123 or 360-696-4494 and leave message.

We all have an opportunity to rid our community of this problem by following the suggested steps of **<u>Record, Report and Remove</u>**. Thank you for your help.

#### PET LICENSING

Licensed pets have benefits:

• They are more likely to quickly be reunited with their owners.

- They receive longer care periods at shelters.
- They are transferred to an emergency medical care facility if found with an injury.

In Clark County pet license applications are required for all cats, dogs and wild or exotic pets older than eight weeks. Once the pet turns six months you will be sent a notice to pay a licensing fee. Applications and forms are online for pet license applications for all pets atwww.clark.wa.gov then click on SERVICES and select ANIMALS AND PETS.

**Fees** - Fees are required for pets older than six months. They are valid for 12 months.

**Cats:** Fertile - \$40 ; Altered - \$20 **Dogs:** Fertile - \$50; Altered - \$25 Wild animal - \$100

**Low-income assistance** - Pet license fee assistance is available for households that have limited incomes and are located in unincorporated Clark County or the city of Vancouver. Only one dog and one cat per household may qualify. Pets must be spayed or neutered.

**Fines** - The fine for having an unlicensed dog or cat in unincorporated Clark County and the cities of Vancouver and Yacolt is \$100 per animal. If an owner who receives a citation licenses the animal within 10 business days, the fine will be reduced by half. A second fine will cost \$200 and a third will cost \$400. Failure to pay a fine could create a lien against the owner's property.

#### Where to purchase a license

Licensing agents may charge a fee of up to \$5 per license.

#### **Mandatory Boater Education**

Weather you cruise, sail, kayak, fish or do yoga on a standup paddle board, you need to know the laws and basics of boating safety.

The Coast Guard Auxiliary Flotilla 78 in collaboration with Clark County Marine Patrol and the United States Power Squadron offers an interactive class to meet the needs of both Washington and Oregon residents to obtain the required Boater's Education Card. Completing the class can also reduce the cost of boat insurance. The About Boating Safety class provides adults and children 12 and older a day of hands-on learning.

Classes are held the fourth Saturday of every month at the Clark County Operations Center (community room -4th building on the left - B-1) located at 4700 NE 78th Street 98665. Class time is 8:30 AM to 5:00 PM.

#### **New Park Development**

The new park presently identified as the West Minnehaha Park is located on NE 17th Avenue just North of NE Minnehaha. The county is running slightly behind in its development. The Clark County Parks Department had hoped to complete the rotor-tilling, leveling and over-seeding the area in the fall of 2017. The space has gone thru a level#1 clean-up thus far.

The grounds will continue to be developed. Their new target date for over-seeding is April 2018. In the meantime this space will continue to be known as an Open Green Space. The General Public is welcome to use the space but must follow Park Rules which are posted at the site.

Money for this park is made possible thru the Park Impact Funds which are generated from fees charged to Clark County Developers for their projects thru out the county.

The Parks Department will be working on an Open House date to meet with the General Public in hopes of selecting an official name for the new park site and start the discussion as to what kind of park does the General Public want. They will have sample pictures of different playground equipment, picnic tables, benches, barbecue pits, asphalt pathways, etc... for review at the meeting.
