Question 1: Please tell us how important the following neighborhood park elements are to you.

Most Important Park Elements

"Very Important" selected (more than 50%)

1. Walking and biking trails	76%
2. Park benches/seating areas	72%
3. Open grassy field	63%

"Very Important" AND "Somewhat Important" combined (more than 50%)

1. Benches/seating areas	96%
2. Open grassy field	93%
3. Walking and biking trails	91%
4. Picnic tables	84%
5. Trees and landscaping	77%
6. Playground equipment	76%
7. Screening plantings	52%

• The least support was for the small skateboarding spot (64% selecting "Not Important") and the basketball half court/sports court (45% selecting "Not Important").

Question 2: Have you ever visited this property before?

Question 3: Is there something special about this park you would like to preserve during the upcoming development process (i.e. trees, views, access points)?

140 people responded to this question (55%).

The primary features the majority of respondents wanted to preserve were:

- Existing trees, including the plum trees
- The small grove of trees
- The hill in the northeast corner (for the views and sledding opportunities)

Additional features/elements respondents were interested in preserving were:

- Views from adjacent homes
- Using the property as an off-leash dog park
- Open spaces
- Peacefulness
- The thicket near the east side of the park
- Blackberry bushes
- Open feeling
- Grassy areas
- Everything
- The access from NW 26th Avenue
- Existing topography

Question 4: Do you have any concerns about this upcoming park development project? If so, please explain.

109 people responded to this question (43%).

Most of the concerns respondents expressed were about:

- The need for additional on- or off-street parking.
- Providing additional access points on the east or northeast side of the park.
- Support for continuing to allow dog owners to use the property as an off-leash dog park in some way. (Note: Off-leash use of this property is currently prohibited by Clark County Code as stipulated on the park rules sign.)
- Opposition to including a skateboarding facility in the park because of concerns with afterhours use, increased crime and vandalism, too much noise and potential conflicts between users in such a small space.

Other concerns were:

• Don't overdevelop it – keep it simple and natural.

- Don't develop it at all.
- Prune the plum trees and remove dead trees.
- Keep the hill and the foot of the hill open for sledding avoid adding obstacles.
- Don't plant trees on the hill.
- Improve visibility and get rid of any hiding places by removing brush.
- Make it a walk-to/bike-to park only. No cars/motorized vehicles.
- Do not allow access from NW 109th Street and 21st Avenue on the east side of the park.
- Don't block adjacent neighbors' views with landscaping or structures.
- Concerned that there won't be anything for teenagers to do in the park and that it will be focused only on small children and adults.
- Ensure that any lighting installed in the park is properly shielded to shine at the ground only and don't use "acorn" style lights.
- Would prefer to see property taxes reduced and the park left undeveloped.
- Funding should go to other programs, like education.
- There are no sidewalks on NW 21st Avenue and it's unsafe to walk on.
- Concerned that the park will attract drug dealers, vandalism gangs and other crime.
- Need to provide a skateboarding spot to help get kids out of the street.
- Don't flatten the hill.
- Concerned it won't be maintained well due to lack of funding.
- Concerned that the park will become a hang-out for teenagers and others at night.
- There already are parks and school properties in the area with playgrounds, basketball and soccer facilities. Keep this one more natural and passive.
- Concerned that any formal, irrigated lawn areas will attract organized sports teams to the park that will disrupt the neighborhood.
- Don't encourage after-hours use of the park.
- Concerned that visitors will park on adjacent roads and block residents' driveways.
- Don't take up valuable park acreage for a parking lot.
- Ensure neighbors' privacy.
- This park isn't needed.
- Don't close it off to bikes.
- We can't afford it.
- Use as little pavement as possible.
- Concerned about increased traffic in the neighborhood because of the park.
- Keep maintenance costs low.
- Park rules should be changed to anticipate the need for long-term camping for homeless people when the economic recession worsens.
- Would like the Sheriff's Office to patrol the park regularly.
- Stop allowing off-leash use of the park. It is potentially dangerous.
- Teenagers have begun hanging out and partying in the "tree house" area of the park. Concerned that this will worsen.
- Don't want to pay more taxes.
- Make the park open and visible to help prevent criminals from hanging out there.
- Some dog owners fail to pick up after their pets, creating unsanitary conditions. This type of use should not be allowed and the scoop laws should be enforced.

Question 5: Do you have any other comments about this project?

• Don't make it another "cookie cutter" park.

- Don't use impervious pavement retain the current level of inflow to our water table and avoid "mitigation."
- We need more dog parks, not more play parks.
- Work with the Vancouver School District to see if access to, and interim use of, their undeveloped property is possible.
- The plum trees in the park provide a link to this area's agricultural past. Don't remove them.
- Make sure the park blends in with its surroundings.
- Provide things for older children to do.
- Very excited about the new park.
- Emphasize the natural environment with places for quiet play and reflection.
- Build it sooner. We've been waiting a very long time.
- Put a placeholder in the plan for a restroom/portable toilet and let the community raise money to install and maintain it.
- Keep it dog friendly.
- Make this park like Kate and Clarence LaLonde Park on NE 99th Street.
- There is a huge need for an off-leash dog park on the west side of town. Put one here and work with DOGPAW to maintain it.
- This park will be a wonderful asset to the community.
- This is a good use of our tax dollars.
- Parts of the park are wet and muddy during certain times of the year.
- Would like to use the park for large family reunions, organization meetings or weddings, but would need adequate parking and restrooms.
- A hedge on the east side of the park would improve the view.
- Provide something for all youth to enjoy that's close to home.
- Don't make this a dog park.
- Don't encourage bicycling on the hill because of erosion problems.
- Level a portion of the property so the hill doesn't take up quite so much space.
- We don't need any more parks.
- Use permeable concrete walking paths for stormwater management.
- The schools already provide places for teenagers to congregate. Keep this park family-friendly.
- Provide playground equipment for older children that is more "extreme."
- Use native plants and limit watering.
- Provide lighting to allow for evening use of the park (watching the sunset and stargazing from the hill).
- Dogs should be kept on the leash in the park.
- Spend as little as possible on development and maintenance.
- Provide a nice quiet place for picnics.
- The park's focal point should be the playground and a walking trail.
- Other local parks have basketball hoops, but none have a small skateboarding spot. Please include one here.
- Make the park senior-friendly.
- Fence the playground equipment for younger children for safety.
- Screening and privacy plantings for neighbors are not important because they will create places for litter to collect, and for people to hide and commit crimes.
- This park will create a great sense of community and help us get to know each other better.

Regarding specific park features:

• Needs multiple access points

- Include a Frisbee/disc golf course
- Plant more trees and flowers
- Include a baseball backstop in the northwest corner
- Include several benches/seating areas on the top of the hill for people to enjoy the view
- Enhance the "fort-like" feeling of the small grove of trees make it a natural play area
- Include parking
- Include a walking path around the perimeter of the park
- Add access points on the south and east sides of the property
- Plant trees and plants that provide nuts and seeds for wildlife
- Include a fenced area for dogs in the park or turned the entire park into a dog park
- Use natural colors on the playground equipment
- Include covered picnic shelters or other covered places to get out of the rain
- Include wall ball
- Include a basketball hoop
- Include lighting for security
- Include swings
- Add a pond or other type of water feature with benches
- Provide off-street parking (a parking lot)
- Include dog waste bag dispensers
- Include lots of garbage cans
- Include a restroom
- Include a skate spot
- Locate benches around the playground for parents to sit and watch their kids play
- Include a paved walking/biking trail
- Provide full-court basketball, not half-court
- Include drinking fountains
- Include playground equipment
- Locate some benches in the shade
- Provide playground equipment for all ages
- Locate walking trail around playground equipment, so parents can keep an eye on their children while they get some exercise
- Include slides
- Include tennis courts
- Include exercise stations along the walking trail
- Include BBQ grills
- Include a baseball diamond
- Include larger signs about the dog leash and scoop laws
- Include climbing, balancing and spinning elements in the playground
- Include volleyball nets
- Provide two separate playgrounds, one for older children and one for younger children
- Include swings that adults can use too
- Include picnic tables
- Provide four or more swings to avoid congestion and waiting
- Provide an open space large enough for playing soccer
