- Provided outreach in parks including marketing, signs, and reader boards
- Launched the pay to park program



2020 Challenges

- Covid-19 outbreak
- Multiple vacancies
- Budget and staffing reductions
- Unprecedented demand on parks during the outbreak
- Seasonal demand on parks
- Increased cleaning requirements
- Decreases in revenues
- Suspension of volunteer program
- Delay in contractual support
- No public meetings leading to suspension of all key parks projects
- And much more





2020 Emerging projects and status

- Camp Bonneville master plan moving forward this Fall
- PROS plan update on track
- Heritage Farm plan approved; Business plan on hold.
- Vancouver Lake milfoil management plan on track
- 179 street environmental permitting on track
- KnotWEED grant on track
- Fish barrier removal grants on track
- Revenue analysis partially complete
- Capital projects- all are on hold

2021 Baseline Adjustments – Balanced budget

- What is it?
 - The Parks and Lands division will be submitting a change request to reduce services in 2021
 - This change will be an addition to the 8% General Fund reduction
- Why is it important?
 - Without this change request, the Parks and Lands budget will not be balanced in 2021
 - There will be a service level impact due to the decrease in seasonal staffing, but this change request will help to sustain Parks and Lands operations during the period of revenue uncertainty associated with COVID-19
- 2021 Budget Impact
 - Approximately \$330K in baseline reductions



Ideas moving forward

- Parks and Lands cost accounting model
- Parks and Lands revenue options
- 1% MPD Levy adjustment; bank capacity?
- Noxious weeds assessment
- Permit and other fees rate adjustments
- Creation of Countywide MPD district
- Replacement Bond for general fund parks
- Fleet Services operational model



2020 Goals

- Deep dive into financial sustainability options for the division.
- Work to unite the division by engaging staff in division-wide projects/work.
- Invest in public and private partnerships by expanding public engagement in strategic planning.
- Implement equity metrics for each core program.
