### Agenda Item III. American Rescue Plan: HOME funding

- HUD HOME-ARP allocations released 4/8/21, Clark County allocated \$2,006,728
- Eligibility: These funds must primarily benefit: 1) those who are, or are at risk of, experiencing homelessness, 2) people fleeing or attempting to flee domestic violence, stalking, human trafficking, 3) populations for whom supportive services would prevent homelessness or housing instability, or 4) households with a veteran family member that meets one of these criteria
- Funding requirements: the bill waives statutory requirements, including commitment deadline, match requirements, and set-aside for CHDOs. Up to 15% of the funds may be used to cover administrative costs
- HUD guidance coming this summer, funds must be spent by 2030
