Program	Description	Funding
Shelter Capacity Grant	Provided by Commerce to increase shelter capacity in Clark County. Funds combined with local Deed Recording Fees to operate the new Howard Johnson hotel as a non-congregate shelter through June 30, 2023. Will be operated by Catholic Community Services.	\$4,321,470
Q&I Shelter	CARES Act funding used to provide quarantine and isolation shelter for people who are unhoused or in need of a place to isolate. Space was also provided for shelter guests so that congregate shelters could limit guests to meet COVID physical distancing requirements. Shelter services provided through December 2020, with support by Public Health. 270 total households were served; 101 through Q&I and 169 through expanded shelter.	\$1,800,000
HCRS Services	CARES Act funding to support local Homeless Crisis Response System programs provide additional resources and services to current program participants. Funds incorporated into current HCRS contracts and spent by 12/30/2020.	\$1,227,145

CSBG COVID	Additional CSBG funds provided through the CARES Act. Funds allocated to existing Community Action Programs through mini-application process to increase capacity of their programs. Contracts operating through September 30, 2022.	\$543,260
Eviction Rent Assistance Program	CARES Act funding provided by Commerce to provide eviction prevention rent assistance. 2,217 households assisted. All funds expended by June 30, 2021.	\$11,904,043.07
ESG COVID	Funds provided by Commerce through their allocation of ESG-CV funds appropriated in the CARES Act. Funds used to support shelter, outreach and RRH programs. Contracts under development for services through September 30, 2022.	\$4,916,760
County ARPA	Funds allocated by county from the American Rescue Plan Act for HCRS supports including outreach, shelter, RRH and PSH services. Contracts under development for services through December 31, 2024.	\$15,500,000

Program	Description	Funding
Treasury Rent Assistance Program	County receives two allocations: through Commerce (T-RAP) and directly from Department of the Treasury (TERA). Funds used for eviction prevention rent assistance. First of two allocations received and allocated to 12 housing providers and several by/for outreach providers. From April 1 through August 25, \$12.7M has been distributed into the community serving 1,646 unduplicated households with rent and/or utility assistance. First allocation contracts in place through December 31, 2021, but can be extended to June 30, 2022 if needed. Second allocation not yet received and must be spent by September 30, 2025.	T-RAP: \$15,426,226 TERA: \$14,131,214 Total: \$29,557,440
