## **Agenda Item II. Approval of September 9 Minutes**

### The August 2021 minutes were approved with a motion by Steve Slegers seconded by Greg Whitson, motion passed.

<u>Community Military Appreciation Committee (CMAC) 9/11 Remembrance (Mike Burton)</u> The 9/11 Remembrance begins with a flyover of F15s at 9:00am. It includes a rifle salute, taps, release of doves, and music by the 204<sup>th</sup> Army band. Ceremony is at Vancouver Waterfront Park. C-Tran is providing a shuttle.

<u>Veteran Homelessness</u> (Jamie Spinelli) Vancouver is addressing homelessness by setting up sanctioned homesites. Columbia River Mental Health will begin providing street medicine outreach. Share's Talking Trash program provides employment for individuals who are homeless. Currently there are 7 sanitation sites available. First reading of changes to the camping ordinance goes before Council on 9/13. Veterans in need of assistance should call Council for the Homeless or Outsiders Inn coordinated outreach hotline (360.839.9964). Outreach is extending to weekends and evenings.

### Committee Reports: Appeals: None, Policies and Procedures: No updates.

July 2021 Contractor Reports & Fund Report: The fund assisted 36 Veteran households. The Veterans Assistance Center received 224 Veteran visits. The Free Clinic did not have any referrals in July. The Fund balance at the end of July was \$902,700.

Thanks to all Veterans organizations for contributing towards \$2,000 needed for Stand Down match. Vancouver's Stand Down event is October 1<sup>st</sup> and 2<sup>nd</sup>, 9am-1pm at the River City Church, 2400 E Fourth Plain Blvd. This event is a drive-thru/walk-thru event; Helped over 60 families with school supplies.

<u>Old Business</u> The Portland Stand Down is September 10, 9am-2pm outside at the Pagoda at the Veterans Memorial Coliseum. They have scaled back the number of providers but will still have clothing, meals and resources.

### Policies and Procedures

Clarification to Emergency Declaration Policy #3.12:

During a state or federal declaration of emergency, certain policy requirements (e.g., eviction notices, shut off notices) may be waived for Veterans who otherwise are eligible. Assistance of any type may be extended up to 6 months during an emergency declaration. Assistance may be further extended if requested by the Clark County Veterans Assistance Center and approved by the Veterans Advisory Board and Clark County finance staff. <u>Assistance provided under this policy during emergency circumstances will not affect a Veteran's timeline for receiving additional assistance after the emergency declaration is ended.</u>
