You do not need to be concerned with the page limit. Typically, we just don't want to see hundreds of pages of materials for no apparent reason.
5.	Is there a specific place in the proposal response that the County wishes to see the ""Certification Regarding Debarment, Suspension, and Other Responsibility Matter" form?	The certification form may be attached at the end of the response. As long as its included, we will accept the RFP.
6.	It is stated on page 10 that resumes are not included in the page count; however, resumes are not mentioned anywhere else. On page 11, Proposal Content, 2. Project Team states that specific employee names should not be included. Does the County wish to receive resumes with the names redacted?	You do not need to redact names. We try to keep the RFP process open and generic where possible. Some respondents may have multiple staff members to participate in any given project, while others may have relatively few. The RFP will be scored the same regardless of the names provided or not provided.
7.	On page 10, Contract Award, 2. Contract Development, a sample version of the contract is referenced as attached to the RFP; however, the sample contract is not in the RFP document, and is not shown with the other RFP-related documents posted under the RFP announcement on the County's website.
