information on this job.

Question #2: There doesn't appear to be a bid/proposal bond form included in the

project documents. Would the County like the contractors to utilize their bonding company's form, or will the County be issuing its own

form?

Answer: Contractor's shall provide a bid bond form along with the bid

package. No specific form will be provided before bid time.

Question #3: Could you verify "Specifications (WSDOT Format)" and

"Specifications (CSI Format)" are part of "Special Provisions"?

Answer: The contract specifications include both WSDOT special provisions

and CSI special provisions.

Question #4: The "Contractor Certification Wage Law Compliance" form doesn't

provide an option for a company which is an "LLC". Can an additional checkbox be provided on this form for bidders which are structured as

an "LLC"?

**Answer:** Contractor's that do not meet one of the individual checkboxes

shall not check a box, and shall fill in the line below stating where

the business was formed.

**Question #5:** The quantities for trees, shrubs, hedges and grasses on the bid tabs do

not match what is on the plans- How do you want us to bid? What is on

the plans or the bid tabs?

**Reference:** 

Answer: The quantity on the plans is correct. The proposal will be modified

by addendum so the number from the proposal matches the plans.

Question #6: It appears the quantity for Bid Item 11 Conc. Class 4000 is

significantly higher than it needs to be. Can clarification be provided if

this bid item is intended to pay for any other work besides the

Bioretention Planter Wall, Curb Stepouts, and Splash Pads at the new

bioretention facility?

**Reference:** LP-101, Keynote 31

Answer: Contractors shall bid with only the following items included in the

Class 4000 bid item: Bioretention Planter Wall, Curb Stepout, splash pads, and the portion of the parking lot entry and exist driveways on parks property. All other concrete will be inclusive

to the items associated with the concrete work.

Question #7: There are two details provided in the project plans for "Cement

Concrete Sidewalk" and for the driveway approach. County standard detail F12 on C110 specifies 2" of CSBC or CSTC under the sidewalk and F17a on C110 specifies 3" CSBC under the approach. Detail 2 on LP-501 specifies 6" of CSBC under the sidewalk and detail 3 specifies

6" of CSBC under the driveway entrance.

Can clarification be provided on the desired depth of rock under the

sidewalk and under the driveway entrances?

Answer: The contractor is directed to bid based on the Clark County

standards in the plan set for both the items listed above. F1, F12,

and F17a.

Question #8: Plan page C105 has a note for the Pour in Place Safety Surfacing which

mentions "underlying drainage" and refers to the landscape plans. The landscape plans don't appear to mention any underlying drainage at this location. Can confirmation be provided that there is not additional drainage required at this location beyond the rock section specified in

detail 4, LP-501?

**Reference:** Plan page C105, and detail 4 on LP 501

Answer: The rock section under the PIP surfacing is an infiltration system

section and shall be treated as an infiltration system. Contractors shall not load the subgrade with heavy equipment and must follow

the infiltration testing requirements on the plans.

Question #9: It is assumed that the Bid item 13 - Drain Pipe 12" Diam. in schedule

A-Park Improvements is intended to be in schedule B-Frontage

Improvements, along with the manhole and water quality catch basin.

**Reference:** 

Answer: The dividing line between Schedule A and B is the ROW line. The

12" Drain Pipe is on Parks property which is Schedule A.

Question #10: Will there be any consideration for an alternative subcontractor for

Poured-in-Place Rubber Surfacing section? Will a Substitution Request

be acceptable? If so, who will I submit request to?

Answer: Contractors shall submit a product that meets the requirements of

the specifications. The specifications do not list specific product

requirements.
