Date: Question #5:	10/26/2021 What is the 153.7 CY Bid Item - 17 Bark or Wood Chip Mulch calculated based on? 3' DIA mulch ring around each plant @ 3" depth? According to the plans, there's 918 plants and 3 shrubs which would make roughly 60 CY of bark. Please advise.
Reference: Answer:	The Bark or Wood Chip Mulch bid item should be to 62 CY. See forthcoming addendum.
Date: Question #6:	10/26/2021 According to the plant schedule & bid item, there's 918 shrubs and 3 trees. When adding up the shrub areas shown on SP pages, there's 23,294 SF of shrub area. Based on the SF of shrub area shown and plant spacing given in the plant schedule on SP-002, this quantity seems very low. With the 23,294 SF given, I come up with needing 4155 plants based on spacing shown on the plant schedule. Please advise. If the plant quantity goes up, wont this affect bid items 17 and 20? Please advise.

Answer:	Both plant number and shrub areas SF are based on habitat mitigation requirements. Suggested O.C. spacing shown in the Plant Schedule (Sheet SP- 002) can be ignored.

Question #10: Reference: Answer:	How does the typical mitigation plan detail 1 on SP-002 relate to the plant schedule and quantities/OC spacing? The typical mitigation detail is to show a typical layout and elevation planting area. It is for reference only. Plant pacing will be less dense than the typical layout
Date: Question #11:	10/28/2021 Transco industries in more the capable of engineering and fabricating this pedestrian Bridge. We have built one in West Moorland Park in Oregon. Just have not done five in the passed three years as your job specs require. Transco would still like to participate on this project.

Date: Question #12:	10/28/2021 Will you require WSDOT AISC Certifications? Typically for a short span bridge structure it is not required. Also will you please provide bridge live load requirements for this project please.
Reference: Answer:	Please refer to 6-21.3 in the special provisions for the bridge manufacturer qualifications. 90 PSF is required.
Date: Question #13: Reference: Answer:	 11/3/2021 Specifications require ACQ preservative treatment for the timber decking on the pedestrian bridge. We are being told by a supplier that this preservative treatment is no longer available. Will Clark County accept alternative timber decking treatments? 6-21.2 ACQ is not the only preservative noted in the special provisions. But yes, Clark County would be open to reviewing alternate preservative treatments.
Date: Question #14: Reference: Answer:	11/4/2021The specifications include measurement for topsoil and amendments, but no section for payment. There is no bid item for topsoil. Where is topsoil paid?8-02.4 MeasurementNo topsoil or amendments will be required.
Date: Question #15:	11/4/2021 The details for the trash receptacle on SP-105 sheet 10 of 30 in the plans does not provide dimensions for the concrete pad and aggregate

Reference: Answer:	base. Please provide dimensions. SP-105 10 of 30 Sp-105 indicates a circle with a diameter of 3'-6". Concrete thickness of 6" and the aggregate base thickness of 8".
Date: Question #16:	11/4/2021 The project requires two years of watering maintenance for plantings. Can the temp access road be left in place for this duration to maintain access for the trucks that will be required for temp watering?
Reference: Answer:	Temporary Construction Access Road Per 8-02.3 in the special provisions only low impact vehicles are allowed within mitigation areas. The temporary road is not being removed in its entirety, the contractor could use the pathway for access but would be required to restore any damage caused by watering/ maintenance activities prior to physical completion.
Date: Question #17:	11/4/2021 We are not totally clear on what exactly bid item #23 (Site Furnishings - Disc Golf Course Sign Frame) is to include. The payment under Part 5 states that payment is to include "all costs associated with delivering and installing signs". Details/notes on SP-106 call out that there is to be 3/4" thick painted MDO plywood sign face installed and a large sign graphic supplied by the County. Please advise on what specifically is paid under this bid item.
Reference: Answer:	PART 5 - PAYMENT, plan sheet SP-106 The only item provided by the county is the Clark County Logo artwork. All costs to provide and install the signs are the responsibility of the contractor.
Date: Question #18: Reference:	11/4/2021 Detail D/SP-110 refers to 1/S-105 for reinforcement bar for shelter slab. Sheet S-105 is not included in the project plans and no other detail has been found. Can Clark County provide sheet S-105 or detail for reinforcement? SP-110
Answer:	Refer to the note on SP-109 and SP-110. This is the responsibility for the contractors. See forthcoming addendum.
Date: Question #19:	11/5/2021 In the specs page 50 Section 8-02.3(6) Mulch and Amendments it mentions Compost Amended Topsoil but there is no bid item for this one. Will there be a bid item added or is this included in Bid Item No. 32 for Site Preparation?

TrueNorth Steel is a AISC certified fabrication facility Certification/Endorsement Types: BU, SBR. located in Missoula Montana. SBR: Certified Bridge Fabricator - Simple is typically approved for short span structures like the 6' x 50' specified for this project. Advanced Bridge Certification is specified and we have this certification in other plants. Will you relax the AISC cert to Simple?

Question #22:	The detail for the disc golf tee pad shows a 4" crushed surfacing base course section under the pad and also calls out for a crushed surfacing top course on top of that, but no sectional depth is provided. Please clarify what the sectional depth for the crushed surfacing top course should be.
Reference: Answer:	SP-107, Detail #4 The typical installation indicates 5" from the top of the eco-grid with concrete blocks to the top of the CSBC layer. The thickness of the CSTC layer could vary depending on the manufacturer of the eco-grid. For example, if Ecoraster Bloxx are used the layer would be approximately 3" thick.
Date: Question #23:	11/10/2021 It is not clear to us exactly what is Owner supplied in regards to Eco- grid and concrete block. It appears that the Owner is supplying ALL
Reference:	 eco-grid (both that filled with topsoil and that that get concrete blocks), and that the Contractor is only to supply an additional 100 SF per bid item #26. Please confirm that the concrete blocks (Ecoraster Bloxx) are supplied by the Contractor. Section 12 9300 - SITE FURNISHINGS, 2.3 Disc Golf Tee Pads,

Date: Question #24:	11/10/2021 The Donated material is not compatible with Ecoraster and does not connect as per the design of the project." - Joe Sharp with EQO PRO (Ecoraster)
Reference: Answer:	EQO PRO is telling us that the Owner supplied Eco-Grid is not compatible with the real product and will not mate up. Please advise. 2.3 Disc Golf Tee-Pads in Addendum #1, parts A, B, C, and D See forthcoming addendum.
Date: Question #25:	11/10/2021 The details in the plans call out the Eco-grid as 13"x13" and also as 12"x12"
Reference: Answer:	Which is correct? SP-107, Details #4 and #5 Ecoraster products are approximately 13" x 13". If the contractor chooses to go for an approved equal product it could be either 13" x 13" or 12" x 12". As long as the overall dimensions of the tee are the same.
Date: Question #26: Reference:	11/11/21 Bid Schedule includes 1,554 SF of "Additional Eco-Grid" and details on SP-107 show Eco-Grid, with concrete blocks and with sand and gravel fill. Spec 12 9300 is unclear if unit price should or should not include procurement of additional concrete blocks. As procurement of additional blocks will have price implications, can the County clarify if contractor should include concrete blocks in the pricing and if so, for the full 1,554 SF or just a portion? Bid Schedule, SP-107, CSI Spec 12 9300

Date: Question #27:	11/11/21 According to the distributor of the Ecoraster Bloxx; the Eco-grid the county has purchased is different than what is called out on 12 9300 2.3(D) and may not be compatible. Can we get some verification on what exactly needs to be supplied and if the county has the Bloxx with concrete inserts, the E50 series, or a different brand?
