Question #1:	Sheet L3.2, irrigation plan B calls for a controller cabinet. Sheets L4.1 and L4.3 both have cabinet standards. I understand that the strong box cabinet is a service cabinet, but does it double as a service and controller? I am trying to put a quote together for getting power out there but the PUD drawing shows a meter by the power pole and an underground line to where the proposed controller cabinet is for the irrigation. I have attached the PUD drawing.

Answer:	Contractors shall bid based on Detail 1/L4.1 as the correct detail. The cabinet is to house both service and controller. Detail 10/L4.3 is superseded.
Date: Question #2: Reference: Answer:	March 7, 2022 Will the house demolition include asbestos removal? No. A separate contractor will remove all asbestos from the property before demolition under this contract begins. A copy of the asbestos report was provided to the bidders so they would be aware of the extent of removal that will occur before the contractual work begins. No lead was found on the property.

Question #3:	Where is the connection for the new electrical service to the irrigation system?
<b>Reference:</b>	
Answer:	The contractor is required to coordinate with CPU Electric during the bidding time to determine the extent of this work, including a secondary pedestal and conduit to the cabinet location, to provide a new electrical service to the irrigation system from the new pole.

Question #4: Reference:	Will the contractor be required to decommission the septic tank?
Answer:	No, the tank will be decommissioned by others. However, the contractor shall bid to remove the tank as part of the demolition of the house.

Question #5:	Is the electrical utility pole work or communication utility work included in the contract?
<b>Reference:</b>	Note 11 and 18 on G1-03
Answer:	No, but the contractor must coordinate with CPU Electric, Comcast, and Lumen during bidding to determine the work that must happen adjacently, and the timelines associated with that work. The contractor shall coordinate with utilities that must be moved during construction.

Question #5: Reference:	Bid Opening Date Change
Answer:	An addendum will be issued delaying the bid opening to March 22, 2022
