The Board of Directors of Evergreen School District No. 114 adopted Resolution No. 6604 concerning renewal of an expiring levy for educational programs and operations. This proposition provides funding for educational programs and operations expenses not funded by the State. If approved, Proposition 6 will authorize the District to levy the following excess taxes, on all taxable property within the District, as provided in Resolution No. 6604.

EXPLANATORY STATEMENT

This proposition authorizes the Evergreen School District to replace an expiring educational programs and operations levy. This is a replacement (not new) tax. The funds collected by this three year levy will continue to support educational programs and operations not fully funded by the State, including staff to reduce class sizes, safety programs, security staff, school nurses, counselors, performing arts, field trips, athletic and extracurricular activities, and local support to bridge funding gaps in Special Education, English Language Learners, Highly Capable and Transportation programs. This levy provides approximately 11% of the District's General Fund budget. Information is available at https://www.evergreenps.org.

STATEMENT FOR

The past two years have been extremely difficult for children. The Covid-19 pandemic took away not only in-person classroom time, but kept them from participating in valuable extracurricular activities that help them become well rounded citizens and better people. Voting Yes for the Evergreen School District EP&O replacement levy shows commitment to the well-being of our students and allows them to not lose out again on these experiences.

The levy, which accounts for approximately 11% of the overall Evergreen School District budget, specifically targets areas the state does not provide full funding towards. These areas include art and music at all grade levels, middle and high school athletics and school security. It also helps pay for special education programs and social emotional support, which many of our students have needed over the past couple years.

As good stewards of your tax dollars, understanding this commitment is a partnership and listening to feedback, this replacement levy was lowered by 17.5% from the previous election. The proposed \$1.70 replacement levy rate is the exact same rate as what currently exists and, paired with the dropping school bond rate, will result in an overall lower school tax rate than what currently exists. This is a replacement levy and not a new tax.

Proposition No. 8 General Obligation Bonds – \$62,565,000

The Board of Directors of Ridgefield School District No. 122 approved Resolution No. 2021-2022-006 concerning this proposition for bonds. This proposition would authorize the District to construct and equip a new elementary school and 8-plex classroom building at the new school site, and a new vocational and general education building at Ridgefield High School, by issuing \$62,565,000 of general obligation bonds maturing within 21 years; and to levy excess property taxes annually to repay the bonds, as described in Resolution No. 2021-2022-006.

Should this proposition be approved?

EXPLANATORY STATEMENT

Proposition No. 8 authorizes the District to issue up to \$62,565,000 of general obligation bonds to construct and equip a new K-4 elementary school, which will initially open as a K-6 school, an 8-plex classroom building at the new elementary school site, and an approximately 18,000 square foot vocational/general education building at Ridgefield High. The District expects to receive approximately \$9,700,000 in State matching funds for the projects. If approved, the District would be authorized to levy property taxes annually to repay the bonds.

STATEMENT FOR

Ridgefield has grown tremendously over the past decade. The Washington State Office of Financial Management tabbed Ridgefield the fastest growing city in the state. It's no wonder why; Ridgefield is consistently a top achieving school district in Clark County while maintaining fiscally responsible governance.

Of the nine K-12 districts in Clark County, Ridgefield has the second lowest overall school tax rate. Ridgefield's more-bang-for-the-buck approach is verified. Of the 295 Washington school districts audited by the Office of Washington State Auditor (SAO), Ridgefield was one of just two school districts to earn SAO's coveted financial *Stewardship Award*. This is clear evidence that our tax dollars are expertly managed.

The last time Ridgefield passed a school bond, 2,823 students were enrolled in Ridgefield schools. Today, enrollment is approximately 3,800 students, an all-time high. Approximately 1,000 additional students have enrolled in Ridgefield schools since voters authorized the construction of additional classroom space. With all of these new kids, it just makes sense that we need more classrooms.

This Bond is necessary to build additional classrooms and enable Ridgefield to keep pace with this incredible growth. It's not a matter of *if* new schools will be built in Ridgefield, it's *when*. That time *is now*. Through proactive planning, the district purchased the land for the new elementary school, designed the school, and prepped the site using developer impact fees. With your *yes* vote, construction can still start this spring, ensuring an opening in time for the Fall of 2023.

REBUTTAL OF STATEMENT AGAINST

485 additional students enrolled in Ridgefield schools this year compared to last year (OSPI Report Card). With hundreds of new homes currently under construction and thousands more planned, growth will clearly continue. The district has tried to pass a bond for three years, always working to minimize the impact on students and families as our schools became increasingly overcrowded. We are at a point where another bond failure will result in ramifications for our community.
