| 1. | Please clarify if the contractor should be proposing entirely virtual delivery of the eight (8) individual and/or small group interviews/ hot washes and the four (4) large group hot washes. Bullet 2, citied to the left, implies that in-person sessions are possible, whereas bullets 6 and 7 both cite virtual meetings. | In person or virtual sessions are acceptable. It is the contractor's discretion to determine the format for Hot Wash / Debrief sessions. Sessions may be conducted in person and/or virtually. However, due to the evolving nature of the pandemic, in person sessions may not be an option, and must comply with state L&I requirements and/or social distancing or masking requirements in place at the time the session occurs. The contractor should include the format they intend to conduct sessions in their proposals and adjust the cost as appropriate. |
| 2. | For the Corrective Action Plan Review, the After Action Report, and the Monitoring and Accountability Plan Meetings toward the end of the project, is in-person delivery for any of these meetings desired? As indicated previously, a virtual format was specified for the hot washes as well as the After Action Meeting in Phase 3, but the meetings in Phase 4 and 5 were not specific in terms of desired delivery. | In person or virtual sessions are acceptable. An effective After Action Review will include representation from those regional partners. |
