DIRECTOR'S REPORT

• **COVID-19 Update**

- Statewide and Countywide, COVID cases as well as hospitalizations and deaths are continuing to decline.
- State Department of Health experienced reporting delays during the Omicron surge.
- State Department of Health also performs routine data clean-ups to remove duplicates and match vaccination records with case records.
- Case rates; hospitalizations rates; death rates are higher for the unvaccinated.
- Omicron BA.2 subvariant is increasing in the UK.
- Omicron BA.2 makes up 35% of cases in the US
- Washington State
 - 71% of people 5+ are fully vaccinated
 - 58% fully vaccinated people 12+ have received a booster
- Clark County
 - 65% of people 5+ are fully vaccinated
 - 56% fully vaccinated people 12+ have received a booter
- Mobile Vaccination Teams
 - Visited 206 facilities
 - Administered 1,253 doses of COVID-19 vaccinations; 1,115 of those doses were boosters
 - 779 volunteered hours logged by MRC
