1. Oregon Department of Transportation (ODOT) Tolling Program

- Hannah Williams, Garet Prior, Zoie Wesenberg and Gillian Garber-Yonts attended and gave a
 presentation on the proposed tolling program and potential impacts on older adults and
 specifically those with fixed incomes.

- Q&A after the presentation included the following key themes:
 - There was a question about whether older adults would get a break of some kind on the tolls. The project team is looking beyond income levels to also consider race, people who are older and younger, people with disabilities, and households without cars.
 - There was a question about race being considered and if the project team could talk more about that. The project team is trying to reach community groups they haven't historically reached before. There are community liaisons connected with communities of color, underserved communities, people with a disability, people who are low income, people who are older, and youth. The liaisons are linked into the community they serve and it seems to be helping with outreach. ODOT is trying to get to better outcomes with better outreach. The project team will be organizing discussion groups in April to get specific community driven input.
 - There was a question about consideration of volunteers crossing the bridge without generating income such as crossing for employment purposes. The tolls would travel with the vehicle and not the purpose for the crossing, however, the project team is thinking about options for the pricing.
 - o If commission members have additional ideas or questions, they can send them to county staff who can forward them to the ODOT project team.

4. Public Health Advisory Council nomination discussion

- Dr. Alan Melnick, the Clark County Public Health Director, is scheduled to attend the regular COA meeting and answer questions about the position.

- CoA member applicant review committee
 - o There are three positions with a term that ends on May 31. The application deadline was April 4.
 - o Future meetings include one to discuss individual scoring and determine candidates to invite to interviews on April 27 and a second to conduct candidate interviews on May 3.
- Aging Readiness Plan subcommittee update
 - The RFP was issued on April 6 and responses are due May 4.
 - o A pre-submittal meeting was held for potential RFP responders on April 14.
 - Future meetings include a pre-scoring meeting on April 25, a chance to discuss scoring and select interviewees on May 17 and interviews with prospective consultant candidates on May 26, 2022.
