Budget update

Dr. Aru Headrick provided an overview of the overall goal and agenda. With the new House Bill 1152, PHAC will be playing a more visible role in the budget. The goal is for PHAC to understand the budget process and how the funding is allocated based on the priority-based initiatives and Foundational Public Health Services (FPHS) fees.

2023 budget process

Jeff Harbison provided details on the 2023 operating budget process, budget highlights and new positions by portfolio. Public health delivered the 2023 budget tools to managers to allow for allocation of the 2023 baseline. Furthermore, the Foundational Public Health Services grant funds increased in 2021-2022 and are expected to expand for 2022-2023.
