I. Roll Call, Approval of Minutes - February 3rd, 2022 (*00:00:11)

- ✓ Alan moves to accept
 - o Tim seconds
 - Approved
- Kyle asks if there have been any updates regarding Small Quantity Generators, as presented by Jessica in the Feb. 3 meeting
 - o None at the moment, but hoping to be able to present more detail at a future SWAC meeting

II. Updates (*00:02:40)

- Clark County Public Health Solid Waste Program
 - o Jessica hoping to have more information about
 - o Updates sent out in advance
 - o Program Manager II position has been offered, and accepted by George Sidles
 - Well known state wide in the Solid Waste industry
 - Previously with the County in early 90's when Environmental Services was still part of Public Works
 - ☐ Went to Dept. of Ecology as a Technical Advisor
 - □ Spent time with Seattle Public Utility, ending in 2015
 - ► Managed \$900m budget
 - Managed family estate
 - □ Retired, but chose to return to work force
 - Expected to start June 1st.
 - Plan to set up introduction meetings
 - o Program Coordinator position will be recruited next.
 - Have postponed recruitment in order to let new program manager (George) decide that role

Motion

- Sarah Keirns is currently working out of class to fill the need, temporarily
- Clark County Public Health Solid Waste Enforcement
 - o Updates sent out in advance
 - Quarterly report submitted to Ecology
 - o In communications over City of Battle Ground facility permit
 - Will need SWAC review

- o West Van MRF lower yard modification permit in process
 - Will need SWAC review
- Have set up online portal to submit reports
 - Have had several submissions, thus far
 - □ Seems to be doing well
 - Tested by Derek Ranta
 - □ Received good feedback
- o Watley Pit has submitted a finding of clean soils, and no further action, in their Q2 report
 - Brian will work with Melissa and Kimberly to get more information to the group
- City of Vancouver
 - o Took over lead of one year contract for Residue Study due to time and staffing constraints
 - Begins May 8th
 - Will sample Multi-family materials, and use findings to asses outreach effectiveness
 - In June, will sample both single family materials from City of Vancouver, and materials from unincorporated and Urban Growth areas of the county
 - Expect report to be completed in September
 - o Had stalled Neighborhood Clean-up events due to pandemic
 - Resuming this year
 - ☐ Have taken time to recalibrate the program to ensure equitability
 - ☐ Have also reduced the number of events due to truck and labor resources
 - ~25 scheduled this year, beginning in March
 - o Spring yard debris and tire coupons sent out in April
 - Will conclude in June
 - Was very helpful after storm created considerable yard debris
- Waste Connections
 - o No representative present

III. Solid Waste Management Plan Update - Pete DuBois (*00:17.03)

- Working with consultant to update workplan
- SWMP is required to be updated every five years
- This update is being done as Phase 3 of the Regional System Study
- Last SWAC meeting, Chapter 4 (Moderate Risk Waste Plan) was reviewed
 - o Toxic materials are being brought to the transfer stations, and shipped to the landfill
 - Hoping to address this issue, specifically around businesses
- Three chapters are being led by technical consultants
 - Chapter 1 Introduction
 - o Chapter 3 Transfer station Capital Improvement Plan
 - Transfer stations have not been significantly improved over the past 20 years
 - Chapter 6 Funding and Financing
 - Will be completed last
- Hoping to present Chapter 2 Reduce, Reuse, Recycle, at the next meeting
 - o This is the education outreach chapter
 - Working with another consultant to get workplans prioritized. Main focuses include:
 - Food waste prevention, rescue, and prevention
 - Contamination within recycling
 - Reducing toxins, and properly managing hazardous waste
- Need to update Interlocal Agreements (ILA) with each city/town within Clark County
 - Serves as flow control document

- o Cannot complete plan until ILAs have been completed
- Consultant contract goes through July 2023
 - o Likely wrap up in Q3 of 2023
- How will Equity be wrapped into each chapter?
 - We do have a diversity/equity project ongoing at the moment, through our grant from Ecology
 - Public Health, as a whole is working on an equity piece
 - Will bring on a consultant to facilitate conversations, specifically about racial equity
- Organics does not include wood waste and construction/demolition debris

IV. Regional System Study Update - Mike Davis (*00:35:06)

- Continuing to move forward, but progress has been slow
 - o Consultant is working on similar negotiations with Columbia Resource Company
 - This has slowed our ability to come through with some bigger ticket items
- Ownership chapter is about ready to come out
 - Will let new manager review prior to SWAC review
- Have received updated scope of work
 - Will get that approved in the next month or two
 - o Will need peer review prior to release
- New regional agency is being discussed as part of the planning process
- Do not have an exact timeline of bringing the minimum fee presentation to County Council
 - o Brian will be working on scheduling that piece
 - o Likely will be unable to have the outreach education portion ready by July 1st

V. Contract Negotiation Overview - Mollie Mangerich (*00:45:17)

- Had presented to various cities/towns with interlocal agreements with the county, regarding the current residential recycling contract
 - Met with Public Works directors, directors of administrative services, and other leaders within the cities, and gave them a broad overview of what was to be shared with them
- Will be going through information recently precented to the Town of Yacolt
 - o Goals included introducing a summary of the negotiated updates to the contract, taking questions and feedback, and gaining support from Yacolt Town Council
 - Provided brief background of current contract
 - Began in 2009, and set to expire December 31, 2021
 - □ Currently operating under 6-month extension
 - □ Hope to have new contract in place July 1, 2022
 - Clark County procures services through Waste Connections, through a contract which the county manages and negotiates
 - Cities and towns have the options to either hold Interlocal Agreements (ILA) with the county and benefit from the contract; or enter into their own contract with a service provider.
 - Current county contract includes multiple aspects of service
 - Curbside collection
 - □ Various options for size and frequency of collection
 - Outreach and education
 - Customer service
 - □ Collaboration between Waste Connections, City of Vancouver, and Clark County, for consistent messaging
 - □ Online services
 - Formal list of recyclable materials
 - Expectations for service vehicles and equipment

¿ Request

- Free recycling collection from county facilities and parks
- o Contract updates include, at no additional cost to rate payers:
 - Every other week recyclables collection in urban services area
 - □ Route efficiency
 - □ Reduced impacts to road and air quality
 - □ Rolled out with automated garbage service
 - Free recycling services for all government facilities and parks
 - Solid Waste Outreach Plan
 - □ Improved coordination among outreach and education partners
 - Formalize Recycling Advocate positions and funding
 - □ Identify and reduce contaminants
 - □ Engage with residents
 - Electric truck pilot
- o Pros to Every Other Week (EOW) service include
 - No price increases
 - Can swap to larger carts at no extra cost
 - Fewer trucks on roads
 - Free recycling collection to government facilities and parks
- o Cons to Weekly Service include
 - Monthly price increase per household
 - New trucks required
 - Tight labor pool
 - Increase average wage rate for CDL drivers
- All communities that have been presented to have had a negative reaction to a switch to EOW service
 - There seemed to be a misunderstanding of reduced service, or believed they were paying for innovation (electric trucks)
 - La Center and Battle Ground are interested in seeking their own contracts
 - Will write an exit clause into the contract
 - County Council unanimously approved
- If contract is not locked in by June 30th, will move to a month-to-month contract, which may create a rate increase
- The garbage contract is a separate contract, and will include substantial capital improvement projects
 - o Garbage collection services in unincorporated areas is overseen by the Utilities Transportation Commission (UTC), not the county
 - o Garbage contract negotiations will be brought before SWAC at a later time
- Sourcing parts for old trucks, or procuring a new truck are both challenging, with long wait times

VI. Future of SWAC Meetings - Amber McKnight (*01:21:46)

- Due to COVID-19 pandemic, an emergency proclamation was issued on March 24th, 2020, which limited in-person gatherings
 - o SWAC meetings have been conducted virtually since that time
 - o Proclamation is set to expire June 1st.
 - SWAC meetings would fall under the Open Public Meetings Act (OPMA) once again
 - ☐ There have been <u>updates</u> to the OPMA during that time
- New OPMA language would require public meetings to be held in a physical location where the public can attend
 - o It is encouraged, but not required, that a remote option be provided
- The OPMA now specifically permits members of the governing body to attend meetings remotely

- While the meeting must be held in a physical location and must allow the public to attend in-person, any or all members can choose to attend the meeting remotely.
- • Beginning June 1st all public SWAC meetings will be held in a hybrid format
 - o A conference room at the Public Health building will be made available
 - ! Will look into options for video feed of conference room
 - o A link will be provided to attend the meeting remotely
 - o Both options will be made available to SWAC members and the public
- Suggestion of an air cleaner/purifier for physical location

VII. Other Business (*01:27:49)

- Mike Mulligan has been looking into plastics recycling
 - Associate Professor Hongfei Lin, from WASU, Pullman, has found a way to convert 90% waste plastics into jet fuel
 - Has extended an invitation to visit his lab and have a discussion of his process
 - o Has been in contact with Pellerin Milnor, in Kenner, Louisiana
 - Has developed technology to separate pulp, aluminum, and other byproducts from aseptic packaging
 - Would like to be able to have various industry personnel present at future meetings
- Alan attended a workshop put on by Sarah Keirns, on "Nothing Goes Away"
 - Spoke about proper recycling and cart tagging
 - o Next workshop on May 11th, centering on Hazardous Waste
- Kim suggests Extended Producer Responsibility (EPR) programs for plastics
 - o WA lawmakers took up potential legislation to look at EPR around household recycling
 - Did not pass
 - Perhaps this could be a future SWAC topic
- Ridgefield Clean-up event went well
 - ~175 residents dropped off hazardous waste
 - ~300 attended event in total
 - o Does not have a report on numbers yet, but appeared to be in line with previous years
- Simone has been hearing issues of bin placement, and wonders if there is a possibility for messaging to the public regarding placement on pick-up days
 - o Julie will share CoV messaging with the county
- Block foam markets have tanked, and collection has been paused
 - Lost a local processor, in Earth Friendly Recycling, as it was not feasible from a cost/benefit standpoint
 - $\circ\quad \mbox{Also trying to be thoughtful with upcoming state ban on plastic foam$
 - Plastic film recycling is still available for public drop-off at all three transfer stations
