NOTE: this activity is currently occurring without approval; this solid waste permit application was submitted by the applicant at the direction of CCPH staff.

Clark County Public Health (CCPH) has been notified that City of Battle Ground (1308 SE Grace AV, Battle Ground APN# 91057042 & 192150000) is planning to modify an existing decant facility that has not been approved by CCPH for the required solid waste handling permit. As an initial step in the review process, CCPH reviewed and approved City of Battle Ground Notice of Intent for Exemption to allow City of Battle Ground to continue to accept wood waste, asphaltic materials and small amounts of metal for recycling that were observed during the September 30, 2021 inspection.

This subsequent solid waste handling permit application has been submitted by City of Battle Ground as they are electing to continue to accept and process street sweeping and vactor waste at this location. City of Battle Ground is currently working with Washington State Department of Ecology to expand the existing, unpermitted, decant facility. The intent of this review is to A) formally review the existing operation and B) concurrently review plans for an expansion in December 2022, if approved. The solid waste handling permit requires the applicant meet permit requirements per WAC 173-350.

CCPH is reviewing the proposed solid waste facility permit application and is seeking your review and comments before opening the review for a public comment period. Clark County's Solid Waste Advisory Commission (SWAC) will issue a formal recommendation prior to CCPH and Washington State Department of Ecology (ECY) making a final determination. Please respond with any specific comments or questions you have, or indicate that you have no comments, using the form below or through a letter or email to CCPH. If you have determined that input from your agency is not needed, please note that and sign the form.
