#### I. Welcome/Introductions

#### II. Approval of July 2022 minutes

Bridget McLeman made a motion to approve the minutes. Motion was seconded by Rob Perkins and carried.

## III. City of Vancouver Affordable Housing Fund and homeless services updates

City Council reviewing affordable housing fund recommendations on September 12. Work group is proposing a \$10M/year bond for 10 years. Plans to be on February ballot.

Safe Stay Communities' review revealed 30 percent of clients obtained housing, and 20 percent obtained employment. Fire protection areas established limiting camping in much of the Burnt Bridge Creek area. On September 12 City Council will review contract amendment with Outsider's Inn to increase funding to open Safe Stay 3.

#### IV. Stipends for board participation, SB5793, update

SB5793, to compensate persons of low income or lived experience up to \$200/day for participation in policy discussions, passed in March. Work is being done to determine how to implement.

### V. <u>July 2021 – June 2022 Outcomes report (Org. Std. 1.3, 4.4, 5.9, 8.7)</u>

Most Community Action programs spent all funds; many Homeless Crisis Response programs were unable to spend all funds due to increased COVID-related funding. Funds not spent are recaptured and allocated to new contracts. Some programs exceeded outcomes expected, where others were impacted by COVID restrictions. Eighty-seven percent of participants completing a satisfaction survey indicated a positive experience working with their program.

#### VI. CNA taskforce creation

Looking for up to 5 CAAB members and 5-7 community members to serve on the Community Needs Assessment Task Force. Members will review the Survey of Needs, engage in forums, provide feedback for the report, and inform the CAAB about Community Needs Assessment completion. Participation is October 2022 through May 2024.

#### VII. 21 linfo program presentation

211info is an information and referral agency that connects community members to appropriate community-based organizations and government agencies online, text, and by phone. The agency also

provides disaster and event information to reduce calls to 911. The agency is working to expand access by offering more multilingual services and materials.

## VIII. <u>lanuary meeting training recommendations</u>

Board members prefer meeting two half-days, January 4, 9-12, and an additional day. Training ideas include overview of document recording fees, the homeless crisis response system, ROMA, parliamentary procedures, funding sources and uses, equity, and more information about SB5793.

## IX. Legislative advocacy committee update

Time to build committee and strategize on what to advocate for in 2023 session. Interested board members to contact Treasurer Topper to be included in the legislative advocacy committee.
