QUESTIONS and ANSWERS

	QUESTION	ANSWER
1.	Can the County provide the most current pricing (that includes pricing escalators) from the last successful winning bidder and the name of the bidder?	Clark County has provided data from the most recent HHW collection event. See pages 3-4 below for complete event data.
2.	Must the vendor be a certified PaintCare hauler to bid this RFP?	Yes, the vendor needs to be a certified PaintCare hauler.
3.	Can the County provide waste volumes for the waste streams listed in the cost templates?	<p>No, we are asking proposers to estimate waste quantities to the best of their ability, based on their experience. Estimate quantities generated at a four (4) hour event with 200 participants.</p> <p>Clark County has provided data from the most recent HHW collection event. See pages 3-4 below for complete event data.</p>
4.	What is the history of previous HHW events in the County?	<p>The County had one HHW event in April 2022 through the state contract, which collected about eight (8) tons of HHW. See pages 3-4 below for complete event data.</p> <p>Previous HHW events were held in 2015 and earlier. Example: The nine (9) collection events in 2015 ranged from 7,000 to 18,000 pounds of HHW collected per event, demonstrating the variability of participation and quantities to expect.</p>
5.	Is the Washington state prevailing wage required?	Yes
6.	Can you explain the funding and the number of events to be held?	The funding section of the RFP states that this contract will be paid for with grant funds from the Department of Ecology. This is on a two-year grant funding cycle, allowing for four (4) HHW events. This will result in two (2) events each year on average.
7.	Must the vendor use the state's PaintCare program for paint collected at the events?	Yes

8.	Can you explain the event sites and who is responsible for site coordination?	These events are typically scheduled to align and tie to the cities/towns recycling day events. Clark County schedules and coordinates the site for the HHW event. Note that the vendor must have the liability insurance requirements as described in the RFP.
9.	Can you confirm what the County will provide, see Section IB of the RFP (ex. toilets)?	Yes, the County provides portable toilets. The County will provide what is listed in Section IB of the RFP.
10.	WA state requires that there be a notification that a mobile HHW collection is taking place. Who takes care of that notification?	Typically, that would be the vendor, but Clark County will be included and notified to ensure the vendor notifies all parties (such as Dept. of Ecology, Fire Department, etc.).
