4:07 PM Business and Marketing Plan Update – Lynde Wallick

Lynde noted that we need to change this to say "Sustainability Plan" on the Agenda.

Lynde discussed the Heritage Farm Sustainability Plan update and informed people when the first meeting is scheduled for, on October 24, 2022 at 1:00 p.m., in Heritage Farm conference room.

Discussed concerns regarding the Steering Committee members and their qualifications to be on the committee itself. Mentioned that the meeting is a public meeting, but that the public may not participate.

4:17 PM Farm Advisory Committee Report – Sandy Brown

Sandy and Kristine mentioned that the Master Gardeners have been doing several tours on the farm, that they occur every month, and that they are going well. Sandy said there has been no requests for projects or activities recently. She mentioned she has been cleaning out files and getting some of the annual reports.

Heather, Erik, and Sandy discussed the difference between the Heritage Farm Meeting members and the Heritage Farm Sustainability Plan committee members.

Kristine mentioned the Harvest celebration that was held at Heritage Farm last Saturday. She said the WSU extension's small acreage program highlights celebrating different farms around the county. This year the extension highlighted eight farms, and Heritage Farm was one of them. Kristine went over what occurred at the event.

4:32 PM Farm Operations Report – Erik Harrison and Rocky Houston

Erik mentioned the activities that have occurred at the farm, listing that all mowing has been done, that Zane organized the machines at the shop, that the area has been winterized, and that pruning and general garbage clean-up have been done. Erik also listed the produce growing at the farm, indicating that the fruits have been organized and named, and that the community gardens have had a lot of activity. He also mentioned that LULAC has started planting on their land.

Nancy mentioned that middle schoolers helped to harvest the carrots, and Kristine talked about the Master Gardener's volunteer program.

Heather indicated they on onboarding a farm manager who will start on October 1, 2022. She also mentioned they have started to receive some of the grants they have applied for, and they will start doing some soil testing to establish a baseline to track their improvements. Kristine added that her, Zane, Justin, the new farm manager will meet tomorrow to talk about the farm equipment and safety.

Nancy mentioned that emergency contact information needs to be posted at the farm. Erik informed her that we are working towards that goal and more information is to come.
