Goal to build 36 units of gated, secure housing for homeless female veterans on land owned at 5118 NE St. James Rd, with on-site manager. Occupants are able to stay as long as they are working towards rehabilitation. Have raised nearly \$600,000 towards development.

Bylaws

Recommended changes included: Section 3.1, CCVRC to CCVAB, and to include members at large in quorum. Section 6.1 changed to require minimum meetings to 11 per year. Both recommendations passed on motions.

Policies and Procedures

Changes to the following sections were approved on individual motions. These will be presented to the County Council in January.

- Section 2.3, to verify veteran status through State Query and Response Exchange System.
- Section 3.1, to remove line ensuring funds are used only when other veteran resources have been exhausted.
- Section 3.4, to increase amount for additional charges associated with rent to \$1,200.
- Section 3.4.2, removing restrictions on move-in fees.
- Section 3.4.5 removes other fees statement of security deposit and adds application fees to 3.4.6.
- Section 3.7, transportation assistance, reflects C-Tran provision of passes to veterans, and revises wording for assistance for vehicles.
- Section 3.9 adds eligibility of burial services to all discharge statuses.
- Section 3.11.1 covers only repairs necessary for safe operation of the vehicle.
- Section 4.2 removes certification of CSOs.

The fund assisted 51 Veteran households. The Veterans Assistance Center received 403 veteran visits. The Free Clinic served 3 veterans in July; the August report is not available. The Fund balance at the end of August was \$656,086.
