## **Hybrid Meeting Attendance Information**

In order to conduct in person meetings at the County there are some ground rules and technology limitations:

- 1. Social distancing remains in effect 6 ft. spacing needs to be maintained within the meeting environment, seating will be adjusted accordingly.
- 2. Wireless microphones will be in use in the meeting room and will need to be muted when the user is not speaking in order to prevent feedback in the audio feed. Also, please speak directly into the mic (+/- 6" works best) when talking
- 3. Staff will be monitoring and moderating Teams and may ask participants to make adjustments.
- 4. Expect some glitches in the remote/in person interface as we learn how to conduct effective meetings in this format.
