Ridgefield Hall & Elm improvements Request: \$232,470 CDBG Presenter: Grant Williams Upgrades water line, reconstructs severely damaged sidewalk and street, and adds ADA ramps on Hall and Elm between 1st and Railroad Avenues.

Battle Ground NE 1st Street Sidewalks

Presenter: Mark Herceg Add sidewalks, including curb, gutter, lighting, storm drainage, and ADA improvements on NE 1st Street between NE 3rd Avenue and Central Park, leading to high school.

Camas NW Benton St improvements

Presenter: Allen Westersund Improvements to road, sidewalk, curb ramps, and sanitary sewer line, on Benton, NW 14th-NW 16th. Roads and sanitary sewers were originally constructed in 1913 and 1926.

Washougal Hamlik Park basketball court improvements

Presenter: Dave Scott In combination with funding awarded with 2021 CDBG funds, project expands installation of a half basketball court to a full basketball court, along with restores other items eliminated from previous awards due to cost, and includes other park improvements.

Acquisition of not-yet built units for housing people escaping homelessness to encourage stability. Will apply for Low-income Housing Tax Credits and acquire private mortgage to complete the funding package. Constructed property to include 23 mixed income units at 9913 NE 13th Avenue.
