Comments from the Chair - None at this time

PVJR - Nathan Bruce

- Record Levels
- State of the railroad is good
- Final walk-through of rehab project minor items left, otherwise looks great
- Eric working on 1.75 million grant now down to 1 million
- Tax credit bill passed floor of house

BYCX Activities – Randy Williams

- Focusing on maintenance
- Scheduled runs should start Mother's Day weekend, subject to equipment availability
- Received final parts for steam engine
- More work on clearing trees
- Accident around MP 18.7 (Heisson Store) About 40' of track damaged
- Landowner will take care of one private crossing (around MP 24.6) with assistance from BYCX landowner has
 access to timber mill

County Activities – Kevin Tyler:

• RRB 1230 – \$1.5 million grant for track/roadbed rehab work on lower section up to Battle Ground

- Will be closing out contract in the next couple weeks
- GCB 3592 \$2.7 million grant status (Bridge repair and then more roadbed rehab mostly in northern sections)
 - Amendment to grant to clarify scope of work and extend until June 2025
 - Under contract now with OTAK who will be helping get the bridge repair project out to bid kick-off meeting is Wednesday this week John asked if the meeting is just for priority 1, 2, and 3 bridge repairs once those are complete PVJR would take responsibility for south line county would still have responsibility of north line until PVJR takes responsibility for that John asked about insurance and Kevin will look into that
 - Working on getting another request for proposals out which will be for a consultant to help put the roadbed rehab work out to bid
 - o Will package money from 3592 with money for 1249 bidding will go all at once
- GCB 1249 \$500k grant from State of Washington
 - Money being packaged with money from 3592
- Signal Repairs
 - o St. John's and 119th St are back in service
 - o 72nd Ave waiting on materials that are out about 6-7 months Summit Signal will finish project then
- Bridge Inspections and Bridge Management Program
 - o Under contract with KPFF will help us do annual inspections and update bridge management plan
 - Safe load ratings of bridges so we know capacity
- Open Public Meetings Act Kevin will send email to new members

Unfinished Business - Dan Weaver

- RRAB bylaws Dan has concerns and will discuss with John and Kent and come back with recommended changes
- RRAB County Code Change
 - Code has been reviewed by attorney and confirmed it will require and ordinance goes to council in form of public hearing – attorney asked about keeping seats open for a period of time and specify the time period – ready to move forward with minor change – Kevin will bring to next meeting
- Freight Rail Dependent Use (FRDU) and Senate Bill SB 5517
 - No movement since last time Dan reported
