(1) WELCOME/NEW MEMBERS/APPROVAL OF MEETING MINUTES (Alan Melnick and Sandra Brown)

(2) PHAC UPDATE

- Update on nominations and recruitment for vacant positions (Alan Melnick & Sandra Brown)
 - PHAC has one vacancy for the Youth representative, and the Board of Health is advertising for this
 position. We have received one application that the Board of Health is currently reviewing. This
 position will be opened until filled.
- Membership/Nominations committee (Sandra Brown)
 - The Membership/Nominations committee will help recruit members when there are open PHAC positions, will assist in sending information out to potential new members and will review applications/letters of recommendation for a position.
 - Current members of the Membership/Nominations committee include Sandra Brown and Michelle Stickley. Marla Sanger expressed interest if no other members of PHAC are drawn to participate on this committee.

- PHAC in person meeting (Sandra Brown)
 - PHAC Executive committee has decided to hold an in person meeting on June 27th, 2023.  - We are looking to hold in-person PHAC meetings on a quarterly basis and keep the remaining monthly meetings virtual.

(3) EXECUTIVE COMMITTEE UPDATE

- Harm Reduction Center/Syringe Services Program (PHAC ad-hoc review team)
 - PHAC ad-hoc group convened on April 14, 2023 to pilot the use of the draft advocacy decision tool. The ad-hoc group consisted of Sarah Garber, Nissa Buchanan, Peggy Carlson and Marla Sanger. Materials were reviewed in advance and scored using the decision-making tool. Ultimately the group came to a consensus and decided that this is an issue we would like to advocate on behalf of for Public Health and to draft a letter that would be presented to the Board of Health on April 26, 2023.
 - o Testing the tool allowed for feedback on how to adjust and utilize it better in the future.
 - Some key points are that the Harm Reduction Center/Syringe Services Program includes evidence-based services that prevent the spread of infectious disease while providing a critical community access point and referral to substance use disorder treatment for individuals who inject drugs. In addition, the services provide screening for HIV, Hepatitis C and sexually transmitted infections, access to treatment for those who test positive for these conditions and access to preexposure prophylaxis for people who test negative for HIV yet are at risk for infection. Furthermore, research has shown that these services reduce the amount of syringes discarded in the community. The use of these services is based on trust, and we want people who inject drugs to be treated with dignity and respect when they access services within our community.
