Emergency Medical Services Regular Property Tax Levy

The Washougal City Council adopted Resolution No. 1230 which authorizes the City to fund emergency medical services with a regular property tax levy. This measure would impose regular property tax levies of \$.50 or less per \$1,000 of assessed valuation for each of six consecutive years beginning in 2024 to replace an expiring emergency medical services property tax levy as authorized by RCW 84.52.069.
