### Portland Vancouver Junction Railroad (PVJR) – Nathan Bruce

- June numbers continued to trend upward
- No accidents, injuries, or incidents to report
- OTAK has been out and will put together a bid towards mid-July
- Hired contractor to perform weed control per county request
- Removed some trees adjacent to neighbor's property that might have been ready to topple

#### Battle Ground, Yacolt, Chelatchie Prairie Railroad (BYCX) - Randy Williams

- Steam engine is in 1472 inspection should be ready to go late July or early August
- Minor car cleaning and maintenance
- Had a runner's group out and next weekend will probably get robbed
- Will be taking OTAK engineers to inspect bridges 20, 23, and 25
- Met with contractor about maintenance building

### **County Activities – Denielle Cowley:**

- GCB 3592 \$2.7 million grant status (Bridge repair and then more roadbed rehab mostly in northern sections)
  - OTAK completed survey for all bridges, completed design review for bridges 6 and 12, and they are targeting 60% design in later August
  - $\circ$   $\$  Roadbed rehab RFP is complete and contract negotiation is commencing

- Bridge Inspections and Bridge Management Program
  - o KPFF is working through the load rating analysis and first draft of a plan for inspections

# Public Comment – Dan Weaver

- Jim Malinowski (RRAB Member) Would like to meet with Dan to talk about North County and how to approach it as he feels the railroad is very important to them and wants to make sure it is preserved and available for future use
- Michael O'Connell Agrees with Jim –there is a lot of industry on the RR line Discussion about the Lagler property, industrial property, potential jobs, property taxes, helping the school district, poor infrastructure in north county the public needs to be educated may want to show how we would buffer the property from the surrounding areas.
- Mark Daniels (RRAB Member) how do we present information about the benefits of the railroad in terms of industry, taxes, jobs supported, shows the potential of what future development looks like along the railroad.
- John Shaffer (RRAB Member) discussion about tax benefits of Lagler property specifically and what it would mean if the property was zoned for industrial.
- Daniel Weaver (RRAB Member) discussion about projects listed by the Columbia River Economic Development Council whose needs could not be met with freight rail service.
- John Hansen (RRAB Member) discussion about how industry pays for schools and having the schools help with outreach.
- Jim Malinowski said there are several places that thrive alongside railroads he believes people that are opposed to the railroad are using scare tactics and claiming adverse impacts that don't happen.
- Steve Jagelski wants to know how to get information out to the public may be time for the RRAB and county to work together may need to go beyond the county for money.
