Meeting Minutes – September 12, 2023

AMENDED MINUTES:

- OCTOBER 27, 2023, BASED ON DISCUSSION DURING OCTOBER 10, 2023, MEETING.
 - The report presented by Michael Torres, "Homeless Program Outcomes and discussion on gaps in services" presentation, was updated on 10/12/2023, minutes now reflect updated numbers. In addition, the source document on the 2022 annual system data that is posted online was updated. <u>ZIP-COUNTY-FIPS_2018-03.csv</u> (councilforthehomeless.org)

ECHO Chair, Clark County Councilor, Gary Medvigy, called the ECHO meeting to-order.

ACTION: Moved by Mayor Anne McEnerny-Ogle to **APPROVE** minutes for August 8, 2023. Councilor Michelle Belkot seconded the motion. All aye/motion passed.

HOMELESS PROGRAM OUTCOMES AND DISCUSSION ON GAPS IN SERVICES (continued)

- Presented by Michael Torres
 - Where are people experiencing homelessness from.
 - Adults that voluntarily provided their last address before they became homeless.
 - That's over 80% of the people that touched the system and got assessed for housing to receive services.
 - Presented by zip code throughout the County and States.
 - Washington State has 4,643 people which is 87.2% of people that are homeless.
 - Clark County 81.0% = 4,310
 - Vancouver 46.0% = 2,447
 - Total number recorded of adults experiencing homelessness in 2022 was 5,324.
 - Based on data and word of mouth it appears that it is easier to access services for homelessness in Portland than in Vancouver.
 - There is a one-night (last night) requirement of homelessness to receive services from Council for the Homeless.
 - What are people experiencing homelessness saying caused it? (Self-Reporting)
 - Cannot Afford Housing 25%
 - Domestic Violence 15%
 - Household Crisis 11%
 - Eviction 8%
 - Substance/Alcohol dependency 4%
 - Racial Disparities
 - People of color are significantly more likely to experience poverty and homelessness in Clark County, Washington.
 - GAPS
 - Improve coordination between Homeless Continuum of Care and Mental Health/Behavioral Health Systems.
 - o Increase Outreach, Shelter, and Supportive Housing
 - Increases in Shelter AND Supportive Housing capacity.

- Without a continuum of care and services...
 - If a community does not have tools to assess needs, coordination, and measurement:
 - It cannot identify or prioritize populations effectively for services or improve/adapt.
 - Without service options (mh/bh, shelter, housing, supports) to connect persons experiencing homelessness to:
 - Outreach Teams are left to hand out water, address basic needs.
 - Without exit ramps for Shelter or Transitional Housing into long-term stability:
 - o Shelter beds fill and stagnate, and utility and "livability" of shelters deteriorates.
 - Without effective Outreach and service entry coordination process:
 - Supportive Housing will not access the populations that need it.

- Homeless Action Plan, Planning Process
- Phase 1: Individual meetings with stakeholders and elected officials County and CFTH Staff will participate in the discussion and facilitation; September 2023 January 2024
- Phase 2: Based on the information gathered in individual meetings, community forums will be scheduled in each of the above communities at the location suggested by elected officials. This will include service providers i.e., behavioral health, SUD, medical, law enforcement; local government, general community, and target populations.
 - o Community Forums/Surveys Scheduling; February March 2024
- Phase 3: Community Forums Facilitating/Gathering Information; April June 2024
 - o Receive and review updated HAP guidance state plan and strategy objectives; June July 2024
- Phase 4: Create Draft 1 of HAP; June August 2024
- Phase 5: Create Second Draft of HAP; August October 2024
- Phase 6: Draft is submitted to ECHO and COC Steering Committee for reviews, edits, and approval; November December 2024
- Phase 7: Prepare to submit plan to commerce.
- Homeless Action Plan Planning Process, January April 2025
