 - The Homeless Action Plan is where we set out strategies, and that goes up to State and eventually the state is held accountable through HUD.
 - The question is: What is ECHO's role in the Homeless Action Plan?
 - o Focus on where the needs are and work with Olympia.
 - o Internal Communication between the groups and ECHO within the Charter.
 - o Better understanding of the Homeless Action Plan.
 - o Have a member of ECHO on the Steering Committee.

Severe Weather Event After Action Review

- Subcommittee Report Back and Recommendations:
 - Met on February 27th, had a great turn out from members from Savior Church, Living Hope Church, Outsiders Inn, River City, and Saint Paul Lutheran Church, discussed the intended outcome, what went well, what could have gone better, what challenges there were, and can be done differently next time. This was to really look at the system planning that is in place, and there were a lot of learning lessons based on our discussions.
 - 400 people were sheltered.
 - 120 people were provided motel vouchers.

- There was outreach.
- There was discussion around our measure of success should not be there were zero fatalities, there were open wounds, there was someone that almost died, there was someone else that had to be Narcan. There were people not trained, because of the storm.
- Discussion of what could be done differently next time:
 - The Current Faith community can no longer sustain the increased need we have.
 - There are increased safety and security considerations that need to be addressed for our volunteer.
 - More training and expertise in first aid, treating trauma, overdoses, m3ental and behavioral health from everyone.
 - A better comprehensive planning within the Homeless Crisis Response System.
- o The Server Weather Response is no longer just Severe Weather; It's Emergency Response System.
- o The faith-based shelters can no longer liability insurance.
- Solutions:
 - Having a rapid response plan in place.
 - Training and development plan.
 - Looking at public places and facilities to be those places for shelter.
 - Providing that incident command training and bringing in Red Cross, CRESA...etc.
- O Next Steps:
 - Explore the subgroup with the taskforce and invite additional organizations to the table.
- A systemic overall issue, non-profits plan for the dollar amount they have but the needs far exceed the
 dollar amount. It's difficult to get an adequate or appropriate plan together and implemented, if we aren't
 willing to take a look at what it would take to meet the real life needs that are occurring.

Update on Document Recording Fee Shortfall in 2024

- Update on the conversation from the last meeting related to the state budget that was recently adopted by both the House and Senate and our efforts to ask them to provide additional recording document recording fee dollars to make up for the shortfall that we are seeing.
- The legislature provided an additional \$9M in 2024 and \$34M in 2025 to address the shortfall across the state.
