### Welcome, agenda review and introductions

Clark County officials and members of Kearns & West welcomed everyone to the meeting. Sylvia Ciborowski, Kearns & West, reviewed the agenda and outlined the purpose and desired outcomes of the meeting:

- Environmental Justice Coalition (EJC) and Community Advisory Group (CAG) members get to know one another;
- Introduce key concepts for the project
- Share an overview of the project purpose and need; and,
- Review the roles of the advisory group members and the decision-making process.

Additionally, she reviewed meeting logistics and greeted members of the public, noting that there would be a public comment opportunity at the end of the meeting.

### Members round robin

Members of the EJC and CAG introduced themselves, sharing their organization (if affiliated) and one thing that inspires them to be a part of climate change work in Clark County. Common reasons included a commitment to community, equity, an appreciation of nature, and laying a better foundation for the area's future. ### Project purpose, background, and process overview

Ben Duncan, Kearns & West, shared definitions of key concepts that will be referenced throughout the Climate Change Planning project. Key concepts include environmental justice, vulnerability, resilience, and health disparities. Some definitions were based on recent Washington legislation as well as other state and federal law.

Jenna Kay, Clark County, went over the project purpose, desired outcomes for both the EJC and CAG advisory groups, and shared more information about the Climate Element, which is a required addition to Clark County's Comprehensive Plan according to E2SHB 1181.

The group had the following questions:

- Question: I don't see anything about health in the plan itself. Will there be a health element? Are there any interim goals or checkpoints built into the process as well?
  - Answer: There is not currently a health element in the county's Comprehensive Plan. The topic of health disparities comes up a lot in the legislation (HB 1181) so it is something we will have to figure out how to address. For interim goals, the current version of the Washington State Department of Commerce's guidance document directs us to come up with interim goals. HB 1181 requires that climate element implementation progress be reported and monitored. For instance, there's been a suggestion that the group establish five-year check points to review goals and progress for reaching the policy goals of the Climate Element in alignment with the implementation monitoring schedule.
- Question: Will these slides be available online after?
  - Answer: Yes, they will be made available.

Sylvia went over the EJC and CAG member roles, outlining how the groups' work will inform each other. She noted that specific roles and expectations will be confirmed at the next meeting. Additionally, Sylvia shared a high-level project timeline and topics for subsequent meetings.

Jenna went over group logistics and asked that members complete the Open Government Training in the next few months. She also highlighted a few items covered in the training such as explaining that a quorum of members of an advisory group constitutes a meeting under the Open Public Meetings Act, and that communications (i.e., emails, phone calls, in-person meetings, etc.) pertaining to the project would be considered public records and may be subject to public records requests.

The group had the following questions and comments:

- Question: How does the plan take into account climate plans created by cities within Clark County? What is being done to ensure that they all fit together?
  - Answer: Consistency is key. Under Washington State's Growth Management Act, every county needs to have countywide planning policies. These policies live in the county's comprehensive plan and serve as the way for the cities and county to check if the policies in their comprehensive plans are consistent with the other neighboring jurisdictions' comprehensive plans.
- Question: Will there be translation resources for the process to engage non-native English-speaking communities?
  - Answer: Yes, the county will work with each organization on the EJC individually to gauge what is needed. The county has a translation budget that can cover some translation needs. Some EJC members can help with translation as well. The goal is to have a process that removes as many barriers as possible for people to participate.
- Question: What are the constraints or boundaries for the work of the CAG and EJC?
  - Answer: The group must devise a framework and criteria for creating policies for the Climate Element. If something like cost is important to the group, then that could be a criterion to evaluate potential policies against. Environmental justice is an example of a criteria written into the legislation, so that is an example of something that we have to consider. Other constraints for the project will be based on the Growth Management Act (which incorporates HB 1181) and any other applicable laws, and some will be identified by the EJC and CAG. We will go into more specific details at subsequent meetings.

• One member noted that federal funds are forthcoming for environmental justice and climate work and that individuals should actively monitor and pursue these funds. In conjunction, Washington's Climate Commitment Act is in place, which will result in additional funding opportunities. Failure to engage in the application process may result in unutilized resources.

### **Public comment**

There was an opportunity for public comment. No members of the public commented. Sylvia reminded the public that there is a form on Clark County's website to submit comments at any time during the project and comments can be emailed to <u>comp.plan@clark.wa.gov</u> or submitted online at <u>https://clark.wa.gov/community-planning/comp-plan-comments</u>.

#### **Next steps**

Sylvia reviewed the following actions items for advisory group members:

- EJC and CAG members complete Open Government Training.
- CAG members submit stipend forms.
- CAG members complete the Vision Statement survey by the next meeting (survey link will be emailed after the meeting).
- CAG members respond to scheduling availability survey.
- EJC members submit January invoice forms.
- EJC members work on public engagement workplans, referring to the forms and templates <u>available on the Clark County website</u>, and send a first draft to county staff by Friday, March 1.
- EJC members review the draft Memorandum of Agreement (MOA) for public engagement activities (county staff to send).

She noted that presentation materials and a recording of the meeting will be made available publicly on the CAG website at <u>https://clark.wa.gov/community-planning/community-advisory-group.</u> The next EJC meeting will be on March 4 from 3:30-6:30p. The next CAG meeting is yet to be scheduled.

## **EJC** workplan discussion

Amy Koski, Clark County, reviewed the goals of EJC public engagement and equity work, timeline for engagement activities, and shared an overview of the EJC engagement workplans. CAG members were released from the meeting.

The group had the following questions and comments:

- Question: For each phase of the project, is there a requirement for how many people EJC members need to engage or gather input from?
  - Answer: Those standards can be defined by the EJC members as they know their communities best. There are no official requirements that workplans must adhere to.
- Question: What documents do EJC members need to fill out next?
  - Answer: On the Clark County website there is a template library for EJC members there are three documents that need to be filled out. The most urgent one is the engagement workplan. It isn't essential that EJC members use the workplan template on the website, it is there just to be helpful.

Amy reviewed next steps for EJC members as they relate to upcoming public engagement and workplan development, which are noted above in the "Next steps" section.

Additionally, the group discussed and shared what inspires them to be a part of the EJC and engage their communities around this project. Members highlighted the importance of community, relationships between one another, and a responsibility to do beneficial work for future generations. Members also discussed representation and an obligation to accurately reflect their community's needs and desires in this work.
