Comments from the Chair - None

Portland Vancouver Junction Railroad (PVJR) - No one in attendance

Battle Ground, Yacolt, Chelatchie Prairie Railroad (BYCX) - Randy Williams

- Train robbers showed up the third weekend in July
- Passenger count is about the same as it was last year
- Tickets reduced by 40% due to rockslide
- Questioning expenditures until they get back to full running mode should be able to recover by end of year
- Doing some track maintenance
- Due to rockslide, they are running the 25-ton locomotive
- Once Bridge 25 is fixed they will be able to restore fares to the previous rate

County Activities - Kevin Tyler

- Bridge Repairs Project Update
 - Contract paused while waiting for materials Contractor working on submittals to Construction
 Manager Randy mentioned the age of the trestles and odd shapes/sizes so contractor will need to find the lumber mill, etc. Also said contractor may work six days per week
 - o Still on track to get repairs done this year
 - Dave Rowe asked if we've asked any US representatives for help with the upgrades as money is available – he said the Willamette Shore Trolley has about 5 cross ties leftover from rebuilding and

- maybe they can donate it Kevin will get Dave connected with the Project Manager and will reach out to the policy lead regarding legislative activities
- Randy asked if there is any traction on the repair for the accident at Heisson Kevin said they have asked for a quote and will need a change order on the contract
- Railroad Roadbed Rehabilitation Project Update
 - No update waiting to see how much funding is left after bridge repairs
 - o Project should go out to bid in November
- Member Appointments
 - Waiting for County Manager to act once that happens it will show up on Council agenda
 - o After that new members will have Open Public Meetings Act training
 - o There will be an announcement later in the year for everyone that wants to reapply for another term

Unfinished Business - Dan Weaver

- Open House/Presentation
 - o Nothing at the county or community planning in terms of implementing the FRDU property
 - o Still need to accumulate data so it's available
- Freight Rail Dependent Use (FRDU)
 - Dan provided Kevin with a letter sent to council from the Clark County Citizens United regarding property owners in north county that are holding out to develop their land along the railroad – Kevin will distribute it to board members, and it is available through the councilor's office – More information to come

 - o None

• Public Comment - Dan Weaver

- Steve Jagelski took grandkids to Chelatchie Prairie Railroad and they loved it he wants to compliment the people who are the conductors and how they treated his grandkids also said the train intersects his property at 131st and Lauren Rd and when they heard the train he and the kids went down there and the engineer made a point of waving to him and the kids it stimulates a young person's mind and the kids were asking him several questions he said people talk about how close it is to the schools and he thinks about how it shows future growth or jobs and to not count the kids short
- John Hansen He was at a family reunion in New Mexico/Arizona and there is a railroad that runs from Taos down to Santa Fe that provides entertainment and public transportation - the public enjoys it and it's something Clark County should look at - he also just got back from Alaska and took a train ride from Denali to Whitaker that was a wonderful trip - believes people are short-selling this in Clark County
- Jim Pearson Took a trip on the Verde Railroad in Arizona that went through the country provided box lunch and magazines, and pointed out features and geology - very well organized
- Dave Rowe When he worked on Portland MAX he would take school kids from 148th and Burnside to Ruby Junction for a field trip – every kid wrote to him and young and older kids love to ride the train
- John Hansen Rail field trip growing up in South Dakota on the Old Milwaukee Railroad went through the countryside and the teachers educated the kids so it wasn't just a business process, it was educational also

Good of the Order - Dan Weaver

• Surface Mining Overlay – Will be some action/discussion by the council coming up and we may want to weigh in on something – this is where the gravel will be coming from that Eric was going to haul down the upper line
