

Manual Recount of Commissioner of Public Lands

Primary and Special Election – August 6, 2024

Report to the Canvassing Board at Certification of Amended Abstract

1. Per authorization of the Canvassing Board, on Saturday, August 24, 2024 at 8:30 a.m., staff began the manual recount process. The total number of ballots in the Commissioner of Public Lands race were verified against the votes tabulated by the Hart Intercivic Verity system during the Primary and Special Election.
2. All 136,974 ballots cast in the Primary and Special Election were accounted for and verified in the manual recount.
3. The manual recount of the race was completed, and results verified by precinct.
4. All ballots were processed according to statute by Auditor staff.
5. Differences in the votes tabulated during the recount from the tabulation in the original results were:
 - a. Ballots where the voter crossed out a candidate's name and did not select another choice, but the ballot was not adjudicated, and therefore the ballots were counted for a candidate. The three ballots in question had the vote removed from the candidate and attributed as an undervote.
 - b. Ballots where the voter did not fill in the box with a black or dark blue pen as stated on the ballot instructions, but used a mark in the box that was not able to be read by the scanner (light pencil marks or green ink) and were recorded as undervotes. The three ballots in question have been attributed to the correct candidate.
 - c. Ballot where the voter originally marked two candidates but indicated in writing which candidate they intended to vote for, but the ballot was not adjudicated properly. The ballot was counted as an overvote because the voter's written instruction was made in the ballot margin outside of contest viewable area. The ballot in question has been attributed to the correct candidate.
