2. <u>Feedback from Civil Service Conference</u>? Marla, Leslie, Kristen and Kristyn attended either the whole conference or parts of it. Marla shared that the conference no longer offers a session with a commissioner panel, or a mock hearing. She found those useful and practical in the past. She mentioned that the obsolescence of Civil Service was mentioned again.

Kristen spoke about the new DACA requirement, and how CCSO has taken the topic to the county legal department for guidance, since the conference experts stated that all DACA recipients are eligible to apply for law enforcement jobs in the state of WA per SB 6157 that went into effect on June 6, 2024. There are also issues around the allowance for DACA recipients to carry firearms, only in the execution of their duties as a peace officer and not for personal use, which could have additional implications.

Secretary Harrington Smith shared that Public Safety Testing is going to ask agencies to determine whether they require their PHS to be completed, or not. If not, the agency's profile will not give that PHS access to their candidates. Sgt Skidmore will check with the background investigators to determine action for the agency in this matter. Public Safety Testing will also be introducing a NEW written exam in 2025.

- 3. Enforcement Commander selection process will be held on Monday November 4th.
- 4. Chair Ludolph-Heikkala shared with the commission that Ron Vail, who was a Civil Service Commissioner when she joined the commission forty (40) years ago in 1984. recently passed away. He was 93 yrs old.
- 5. CCSO might be requesting a special meeting of the Commission next week, depending on the outcome of the Rule of 5 interviews for the HR Rep vacancy.
