#### I. Introductions

#### II. September 9, 2024, Meeting Minutes

The minutes were approved following a motion made by Mayor McCoy and seconded by Jim Hodges.

#### III. Program Updates

- Application and Funding Guidelines Update:
  - Staff presented a minor amendment to the UCPB Application and Funding Guidelines to align with HUD guidance. The change allows nonprofits to apply for funding within the city of Vancouver for public facility projects without investment by the city of Vancouver. The county award must still be proportional to the county residents benefitting from the project, but the other funds can be from any non-county source.
- Timeliness and Grant Agreements:
  - The board was updated on timeliness of current projects. Staff shared that they will likely not be timely for May 2025. Councilor Yung commented on the importance of timeliness to not jeopardize funds in the future.
- CDBG/HOME Important Dates Calendar:

A calendar showing important CDBG and HOME dates for the program year (July-June) was provided to the board. The calendar will be updated and provided at the January UCPB meeting along with the annual work plan. This will include meeting dates, report deadlines, and more.

#### Environmental Review Process Overview

Staff provided an overview of the HUD Environmental Review process based on a 3-day training they attended. The overview discussed why environmental reviews are required, the different levels of review and what types of activities fall under each level. Many of the neighborhood improvement infrastructure projects will now require an Environmental Assessment (EA) level review. An EA will be required for projects that change the use of the property such as adding sidewalks where none existed, and when existing infrastructure is changed in size or capacity of more than 20%. Projects will be monitored as they move forward and may need to be reassessed if there are significant design changes. Currently, staff does not recommend taking on any projects that require an Environmental Impact Statement (EIS) as this process is lengthy and the environmental impact for these projects is significant.

The board engaged in discussion regarding the length of environmental processes and the need to be timely with projects and grant proposals. The board requested that staff sends this presentation to all board members so they can forward it to their Public Works Departments.

#### Homeowner Rehab Program Presentation

Dawn Lee, Program Assistant for the Housing Rehabilitation Program, gave a presentation on the program's funding, eligibility requirements, and application process. The demographics of those assisted from 2022-now, including race, age, and gender, were presented along with some before and after photos of recent projects.

#### 2025 UCPB Meeting Planning

Staff presented potential dates and topics for 2025 UCPB meetings, including the proposal of an April meeting rather than a May meeting. Staff requested board members notify them if there are any trainings or discussions they would like to include. Staff are planning to provide a discussion on the return on investment comparison between TBRA and multifamily housing development along with training on Section 3 requirements.






#### **Neighborly Scoring Refresher**

 The "Complete Scoring" tab on the left-hand side allows you to start the scoring process.





## Neighborly Scoring Refresher (continued)



- Score Report will show points awarded and points available.
- Note that not all questions are scored for each application
  - Public Facilities and Neighborhood Improvements have 2 application types: Neighborhood Improvements and Public Facility
  - Asset and Economic Development: score all sections
  - Affordable Housing and Homelessness have 2 application types: Construction and Tenant Based Rental Assistance



## What is an "equity lens"

Scoring applications through an "equity lens" means evaluating proposals not just on their merit, but also by considering how they specifically address the needs of historically marginalized communities and actively work to dismantle systemic inequities, prioritizing projects that demonstrably aim to create fair outcomes for all groups, not just the majority.



#### **Key Aspects to Consider**

- Impact on underserved populations
- Evaluate how well the proposed project targets and directly benefits marginalized communities
- Community engagement
- Assess the level of community input and involvement in designing the project, ensuring the needs
  of the target population are truly represented
- Addressing systemic barriers
- Analyze whether the proposal identifies and actively works to dismantle systemic inequalities that may hinder access to services or opportunities
- Data-driven approach
- Look for evidence that the applicant uses data to understand the disparities within their target community and tailor their project accordingly
- Organizational capacity and community representation
- Evaluate whether the organization has the experience, expertise, and internal structures necessary to effectively serve diverse communities and address potential equity concerns



#### What is Scoring Bias?

Bias = Prejudice in favor of or against one thing, person, or group compared with another, usually in a way that is unfair.

#### Types of scoring bias:

- 1. Affinity Bias:
  - Having a more favorable opinion of those similar to us (race, gender, ethnicity, etc.).
- 2. The Halo or Horn Effect:
  - The tendency for a single positive or negative rating to cause raters to inflate or deflate all other ratings.
- 3. The Contrast Bias:
  - Comparing applications with one another rather than looking at each application individually. Can cause raters to overestimate or underestimate a program's capacity.
- 4. The Central Tendency Bias:
  - Causes some raters to score every question on a scale near the center.
- 5. The Leniency or Strictness Bias:
  - Scoring consistently "too high" or "too low".
- 6. The Recency Bias:
  - Leads to overestimates or underestimates if the organization being scored had a recent "good streak" or a recent "bad streak".



#### How to Avoid Scoring Bias

#### Conflict of Interest

- Each scoring committee member is required to verify they do not have a conflict through the following statement:
  - No member of the advisory board shall vote on any matter if
    - they, or a family member, has a personal or pecuniary interest,
    - their vote could benefit any organization in which they, or a family member, is an officer or employee, or
    - they have provided any advice, assistance or guidance regarding any aspect of a proposal submitted in response to this RFA.

#### · Bias in Scoring

- Focus on the content of the application, not outside knowledge
- Score each application and question separately from the others, not as a comparison.

## Overview of CDBG Program

The primary objective of CDBG is the development of viable urban communities, *principally for low/mod persons*, through:

- Decent housing
- Suitable living environment
- Expanded economic opportunity

Each funded activity must meet one of three national objectives:

- 1) benefits low- and moderate- income individuals,
- 2) aids in the prevention or elimination of slums or blight, or
- 3) addresses an urgent need that poses a serious and immediate threat to the health or welfare of the community which occurred within the last 18 months and for which other funding is not available.

- Strategic and Targeted Investment

## Utilizing Funding

#### 5-Year Consolidated Plan and Annual Action Plan

- Needs determine activities and organizations to fund
- Consolidated Plan Components
  - Housing Needs Assessment
  - Market Analysis
  - Five-Year Strategic Plan Funding
  - Annual Action Plan Funding

## CDBG National Objective

- Each activity MUST meet at least one:
  - Benefit primarily low and moderate income persons
    - Area
    - Limited clientele
    - Housing
    - Jobs
  - Aid in the prevention/elimination of slum & blight
  - Urgent Need This is rarely used with standard entitlement funds

#### 2024 Income Limits

MSA CDBG Income Limits at 80% AMI

**HOME Income Limits at 60% AMI** 

Household Size	60%	80%
• 1 member	\$49,560	\$66,100
• 2 members	\$56,640	\$75,550
• 3 members	\$63,720	\$85,000
• 4 members	\$70,800	\$94,400
• 5 members	\$76,500	\$102,000
• 6 members	\$82,140	\$109,550
• 7 members	\$87,840	\$117,100
• 8 members	\$93,480	\$124,650

## Low & Moderate Income Objective

- Most common objective is Low and Moderate Income
  - At least 51% of program beneficiaries must be low or moderate income
    - CDBG program defines low income as household income equal to or less than 50% of median income
    - CDBG program defines moderate income as household income equal to or less than 80% of median income

#### CDBG Beneficiaries

- Activities affecting multi-family structures or public facilities, including infrastructure must guarantee at least 51% low and moderate income benefit
- Those activities relating to single family developments must serve 100% low and moderate income
- Many Jurisdictions require public service providers to serve 100% LMI clientele w/ CDBG funding
- No project is eligible if there is not at least 51% low to moderate income benefit

## CDBG Funding Categories

Local Program Usage Caps:

**CDBG** 

Public Service (15% cap)

Planning & Administration (20% cap)

2024 CDBG = \$1,567,719

**2024 HOME = \$527,824** 

Planning & Administration (10% cap)

## CDBG Eligible Public Service/Activities

Including but not limited to:

- Services for homeless persons
- Drug abuse counseling & treatment
- Services for victims of domestic violence

- Services for persons with disabilities
- Child care
- Healthcare
- Fair Housing activities
- Services for senior citizens

## CDBG Eligible Project Use

#### Activities

- Acquisition
- Clearance of sites
- Reconstruction/rehabilitation of homes or other property
- Construction of public facilities & improvements (water and sewer facilities, streets, neighborhood centers)
- Assistance to low-income homebuyers in purchasing a home

### CDBG Ineligible Activities

- Completely Ineligible Activities
  - Buildings used for the general conduct of gov't
  - General government expenses
  - Political activities
- Generally Ineligible Activities
  - Purchase of equipment
  - Operating and maintenance expenses
  - Construction of new permanent residential structures
  - Direct Income Payments
