- 3. Public Safety Testing will be changing their testing process on 3/2/25 with a brand-new test. One recommendation is to exhaust the current eligibility list and start a new eligibility list so that there is no cross over between the 2 separate testing processes. More discussion expected with CCSO HR.
- 4. June Civil Service Commission meeting falls on Juneteenth Holiday. The Commission agreed to move the meeting to Wednesday the 18<sup>th</sup>. Proper public notices will be sent out to meet the OPMA requirements.
