Kristen Olson shared news with the Commissioners. The Sheriff's Office will be entering into a contract with an agency that has the purpose of harvesting additional deputy sheriff candidates. Those efforts could increase the number of candidates currently being tested/interviewed by 3 or 4 times the numbers currently being processed. The Sheriff's Office is also in conversation with the testing agency, Public Safety Testing, to

bring them to Vancouver once a month rather than once a quarter. The testing capacity for the Vancouver location is up to 90 candidates. In anticipation of the Sheriff's Office receiving the influx of candidates, Kristen Olson asked the commission if herself and Kristyn McFarland would be allowed to monitor the civil service oral board interviews. The commission did not have an issue and the Secretary to the commission will supply
