

## **Capital Levy for Safety, Security and Infrastructure Improvements**

## Creation of Camas-Washougal Regional Fire Protection Service Authority

The City Councils of the City of Camas and the City of Washougal have adopted Joint Resolution No. 24-018; 1246 approving the Regional Fire Authority Protection Service Plan ("Plan") concerning the creation of a Regional Fire Protection Service Authority ("RFA") under RCW 52.26.

This proposition would approve the Plan and create an RFA to be known as the Camas-Washougal Fire Authority, effective September 1, 2025, to provide fire protection and emergency medical services in the City of Camas and the City of Washougal. The RFA would be funded by property tax (\$1.05 per \$1,000 of assessed value).
