#### I. Welcome/Introductions

# II. Approval of January 10 and January 17, 2025 minutes

Brondalyn Clark made a motion to approve the January minutes as presented which was seconded by Amy Roark. Motion passed unanimously.

#### III. July – Dec. 2024 Outcomes Report (Org. Std. 1.3, 4.4, 5.9, 8.7)

Community Action Programs are on track for spending. Any programs that have issues will receive intervention from their program coordinators. CSSWW and Share Hunger Response Programs have spent out their funding.

Homeless Crisis Response System programs are about 50% achieved overall. Some intervention has been taken for programs that need assistance with completing quarterly reports.

Overall, participant satisfaction is at 90.8%, with 554 participants. Almost \$600,000 in volunteer hours. 94 grievances were received, and 76 were resolved. No concerns. For race, most people served are white, with the second largest population being unknown/other. 1,405 people identify as chronically homeless, 307 as veterans, and 2,728 as disabled.

### Questions and Comments:

- Q: Are grievances repeatable or are there many of the same kind of grievances across programs? A: Staff shared that while there has only been an instance of a single agency receiving the same grievance multiple times.
- Q: Could staff share how race data compares with the City of Vancouver's racial distribution?

  A: Staff shared that Council for the Homeless has a page where you can find the County's data compared to that of the City's.
- Q: Is there data regarding people's last permanent zip code available?
  - A: Council for the Homeless does have this information, but it is not CAP specific. Staff will try and have this data the next time the Outcome Report is shared.
