#### Proposition No. 1 Levy Lid Lift

The Board of Trustees of the Fort Vancouver Regional Library District adopted Resolution 2025-01 concerning its regular property tax levy. This proposition would authorize the District to restore its regular property tax levy to \$0.50 per \$1,000 of assessed value for collection in 2026 to provide continued funding for the Library District's operation and maintenance. The resulting dollar amount of the 2026 levy would be used for the purpose of computing subsequent levy limitations as provided by RCW 84.55. Should this proposition be approved?

To vote, use your official ballot.

#### **EXPLANATORY STATEMENT**

State law allows Fort Vancouver Regional Library (FVRL) to collect up to \$0.50/\$1,000 of assessed property value per year for general operations and maintenance. However, due to tax limitation laws, FVRL has collected at a rate below \$0.50/\$1,000 since 2014. Passage of this Proposition would restore FVRL's levy rate to \$0.50/\$1,000 for 2026. The resulting 2026 levy amount would then be used to calculate all applicable tax limitations thereafter.

Approval of this Proposition would provide funding necessary to sustain FVRL's operations and maintenance. Rejection of this Proposition would mean reduced funding for FVRL, necessitating reductions to library operations and maintenance.

#### STATEMENT AGAINST

While library services are a pillar of a thriving community, the FVRL Board of Trustees has failed in their duty to utilize taxpayer funds in a prudent and transparent manner and has not earned the right to request an increase from the people they serve.

Since 2022, FVRL has failed to participate in the WA state public library wage study, leaving taxpayers in the dark as to how much of their money is going to executive salaries rather than being invested in the community. According to the WPEA, FVRL's current Executive Director was hired at a salary of over \$200,000 while frontline workers made just over minimum wage. This would make FVRL's Executive Director the second highest paid in the state, despite FVRL only serving the fifth largest population. Instead of pledging to cut bloated executive salaries should their levy fail to pass, the Board has instead declared that they will immediately cut frontline staff hours and services by 30%.

In addition to their lack of transparency, the Board and FVRL management have continually conceded to the demands of MAGA extremists, failing to provide vital services to marginalized groups, especially LGBTQ+ kids and families. Despite all other surrounding library systems providing these services, some with smaller budgets and populations, FVRL continues to cower in the face of a vocal minority.

Until FVRL and the Board can prove they are dedicated to financial transparency and properly serving our community, I urge you to vote no on this levy lift.


