Consolidated Plan Presentation, Elizabeth McNannay

- Working with Clark County's Community Development Block Grant (CDBG) and HOME Program (HOME) staff to prepare the County's 2025-2029 Consolidated Plan. The plan will provide direction for how CDBG and HOME funds will be spent to support low-and-moderate income residents of Clark County.
- Examples of eligible programs for CDBG funding are housing rehabilitation, economic development, and public facilities. HOME programs support affordable housing and tenant based rental assistance.
- The next steps of the plan are to complete community engagement activities, present the plan draft to County Council, and submit the plan to the department of Housing and Urban Development (HUD).
- In 2023, efforts to support homeless veterans were strengthened and 2024 data showed a 25% decrease in homeless veterans compared to 2023.

Questions and Comments:

C: The number of homeless veterans in Clark County is more than what was presented today.

A: The data was provided via the Point-In-Time count and is likely not 100% accurate.

Q: Can this money assist with rent and mortgage for veterans struggling to make payments?

A: Yes, temporary assistance can be provided for up to 90 days. The Board was encouraged to attend County Council and Urban County Policy Board meetings to share the need for these programs.

Q: With public services being an important community need, will they be funded in the future?

A: This will be the recommendation to the Urban County Policy Board based on feedback received.

Clark County Veterans Assistance Center Presentation, Judy Russel

- An overview of the staff and services available at the Clark County Veterans Assistance Center was given.
- The importance of grants and fundraisers to the current and future services provided by the CCVAC was stressed.
- Services provided through the Veterans Assistance Fund were outlined and include food vouchers, rental assistance, and dental assistance.

Questions and Comments:

Q: How many veterans are repeatedly being served?

A: About 1/3 of visitors to the center have been assisted multiple times.

February 2025 Contractor & Fund Reports

- CCVAC: 55 Veterans served in February, services totaling \$34,044.97. 45 male veterans, 8 female veterans, 1 widow, 0 other veterans. 15 denials, 0 subject to appeal. 584 visits to the center for essentials and food, 862 sack breakfasts/lunches provided and 44 food boxes provided. 3,396 total pounds of food. 716.5 volunteer hours, totaling \$29,376.50 in value.
- Free Clinic: 3 Veterans served in February. Services totaled \$1,607 in value; billed \$736.76.
- VAF Fund: February revenue: \$47,609.55; expenditures: \$74,535.62 fund balance: \$462,038.50.

Questions and Comments

Q: Data shows that there were four widows served in February, why does the presentation only show one?

A: Staff will confirm the correct number and update the board.

Code of Conduct Discussion and Approval

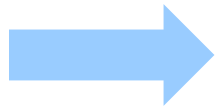
- Tonya Wark shared the opportunity for the VAB to have a booth at an upcoming event.

Motion to adjourn by Michael Langsdorf and seconded by Lloyd Bowman. Approved unanimously.

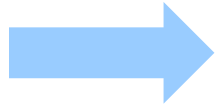

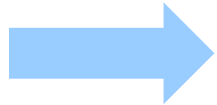

Agenda Item V. March 2025 Contractor Reports

- **CCVAC**

- 37 Veterans served in March, services totaling \$34,195.55
- 33 male Veterans, 4 female Veterans, 0 widows, and 0 others served
- 9 denials, 0 subject to appeal
- 622 visits to the center for essentials and food. 993 sack breakfasts and lunches and 61 food boxes provided. 4,544 total pounds of food provided
- 544 volunteer hours, totaling \$21,912.32 in value

- **Free Clinic**

- 3 veterans served in March. Services totaled \$1,770 in value. Billed \$703.41.

- **WDVA**

- First quarter: 735 claims, 93% “batting average”, \$1,440,802 VA payments.

- **Fund**

- March revenue: \$56,710.36; expenditures: \$79,551.75
- Fund balance: \$439,197.11 (\$22,841.39 decrease from last month)
