	QUESTION	ANSWER
1.	Would the County consider waiving the DBE requirement of 16%?	This project is funded with a federal grant that has been assigned the 16% DBE requirement. The County is unable to waive this requirement.
2.	Does the County have an open API available for pulling the Wavetronix count station data?	Yes, there will be an open API available to pull the Wavetronix count station data.
3.	Would the County consider a solution that brings much of the data into the cloud hosted platform without integrating directly with ATMS.Now?	Yes, a cloud hosted solution would be considered, and it would not have to integrate directly with ATMS.now
4.	Are the Wavetronix count stations located at signalized intersections or non-signalized locations?	The Wavetronix count stations are located at signalized intersections and at roundabouts.
5.	Does the participating company need to be locally based to Washington State?	Any vendor can participate as long as they get registered with MRSC.
6.	There is also a section written in Russian – do you have an English version available?	The section in Russian is preceded by the same information English as part of a requirement for Title VI.
