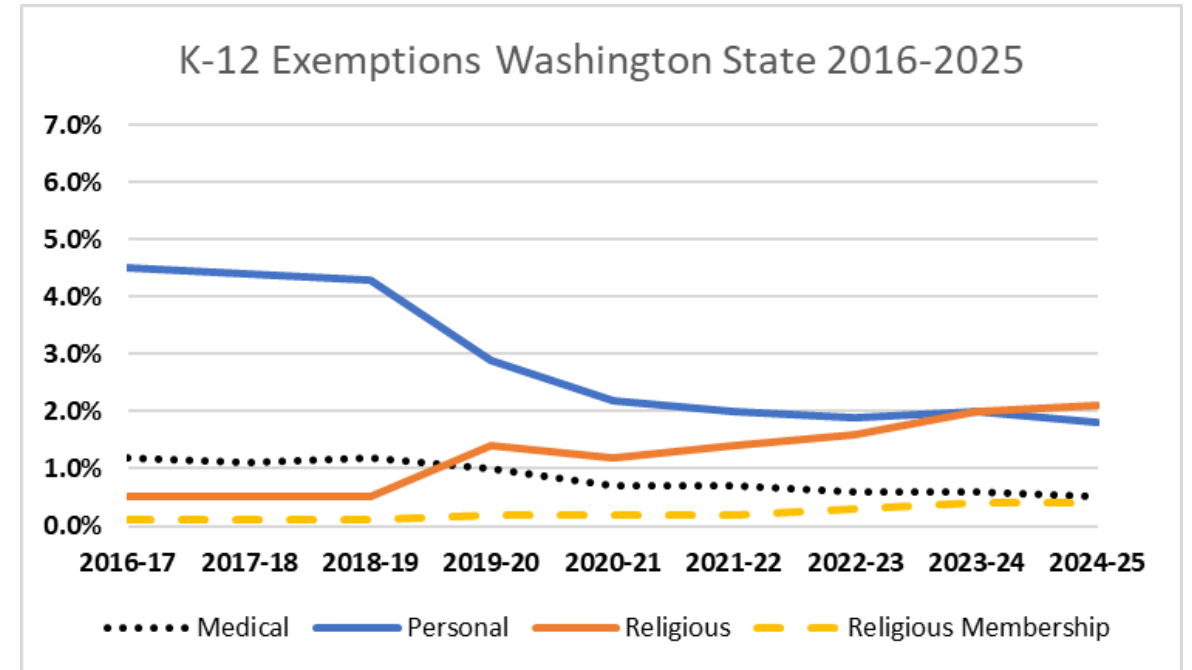

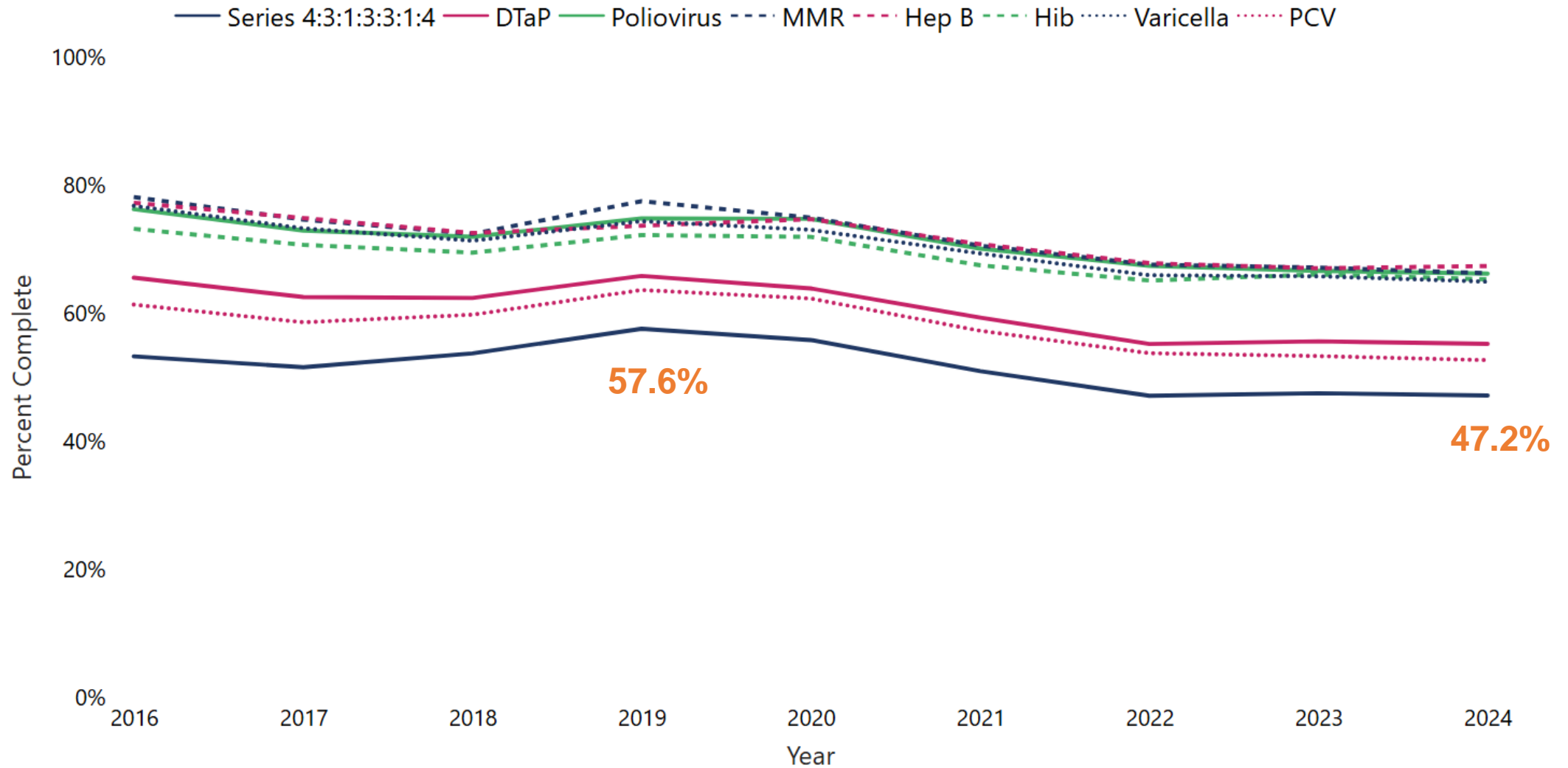
School Immunization Data



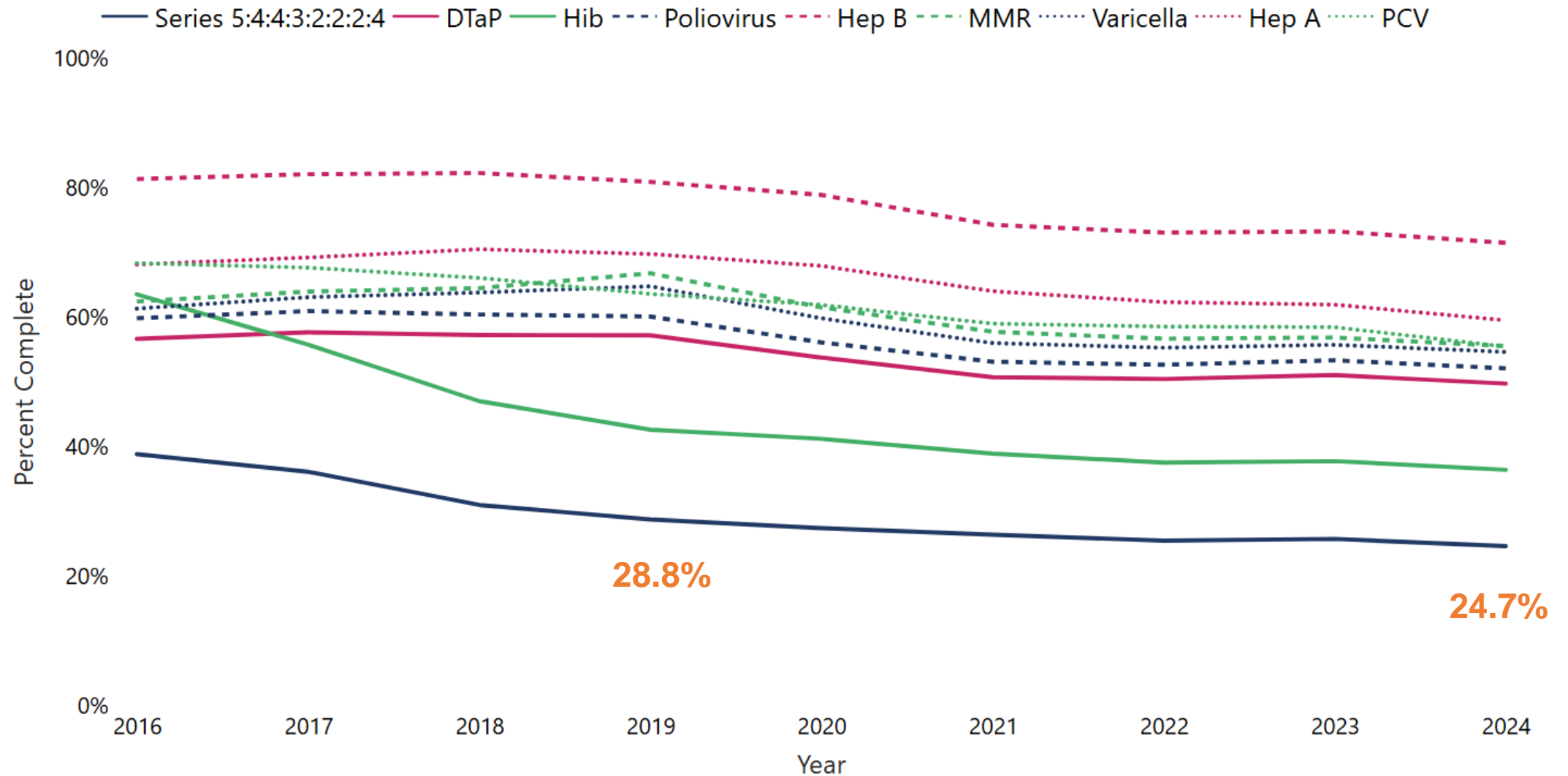

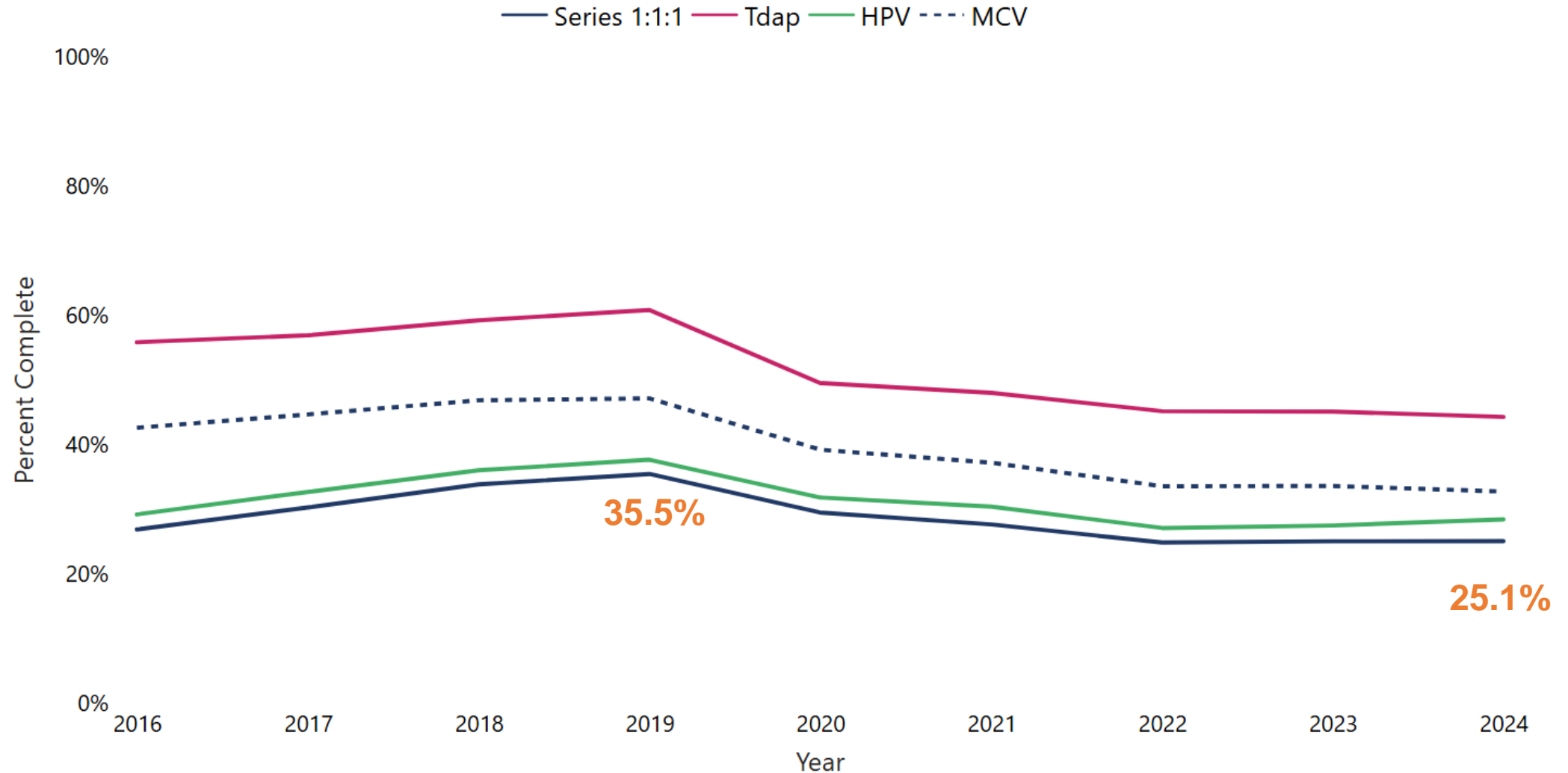
WAIIS Data 19-35 month olds

Immunization Program Projects

- Clark County Immunization Coalition, cont.
 - Relaunched in May 2024
 - Quarterly meetings:
 - Updates on immunization related topics
 - Opportunity for networking
 - Partnered with Within Reach, WA DOH, and other partners to plan and host Building Immunity, Strengthening Community statewide conference
 - Attendance has grown from 13 to 25 attendees this year.

Tdap & Pregnancy Updates

Pertussis continues to spread in Clark County. Between January and March 2025, Clark County Public Health was notified of 165 pertussis cases. Children under the age of 19 accounted for over 85% of cases.

- 100 cases this year were not up to date on pertussis immunizations.
 - 88 have never received a pertussis containing vaccine.
 - 1 was not eligible to receive the vaccine based on age.
- Among 18 cases of infants under the age of 1, only 1 mother reported receiving Tdap during pregnancy.

Vaccination continues to provide the best protection against pertussis.



Immunization Decision Making During the Prenatal Period

BACKGROUND

Maintaining high childhood immunization rates is important to prevent a resurgence of vaccine preventable diseases in our community. In addition to ensuring access to vaccines, maintaining high childhood immunization rates requires an understanding both of parents' concerns related to immunization and the optimal timing for addressing these concerns by Healthcare Providers (HCPs).



Immunizations: What You Need to Know for Childcares and Schools

What vaccines does my child need to attend childcare and school?

Vaccines are required for children to attend childcare, preschool, and Kindergarten through 12th grade. Your child will need different vaccines depending on their age and grade.

How do I know if my child has all of the vaccines that they need?

Check with your child's Healthcare Provider to see if they have received all of the vaccines they need. If your child was vaccinated in Washington State, you can also view their immunization record in MyIR Mobile.

What forms do I need to turn in?

Immunization records must be submitted on a Certificate of Immunization Status (CIS) form. A completed copy of this form can be printed from MyIR Mobile, or by your child's Healthcare Provider. You may also turn in a print-out of your child's official immunization records from their Healthcare Provider along with a CIS completed by hand.

When do I need to turn in immunization records?

Immunization records must be submitted prior to your child starting childcare or school. It is easiest to turn them in when registering your child.

Immunization Program Projects



- C+C media campaign
 - Adapted a campaign previously created for WA DOH
 - Campaign ran from September to October 2024 receiving 8 million impressions
 - Ads on social media, cable and digital TV, and websites
 - Targeting parents of school aged children
- C+C market research
 - Key informant interviews conducted with vaccine hesitant parents and HCP's.
 - CCPH will utilize this information to develop targeted outreach materials and to direct future program planning.

Is your child starting kindergarten this fall? Now is a good time to schedule a well-child visit and make sure they're up to date on their immunizations.

In Washington, some immunizations are required for students to attend school. This helps to prevent serious illnesses from spreading in schools and making kids sick.

Parents need to submit medically verified immunization records to the school when enrolling their soon-to-be kindergartner. Here is how to get a copy of your child's records:

- Contact your health care provider for a copy.

- Access them easily through the state's MyIR Mobile system: <https://myirmobile.com/>

Did you know: Measles is so contagious that if a person has it, 9 out of 10 people around them who are not vaccinated will also get sick?

The good news is the measles vaccine provides great protection against illness. Two doses are 97% effective at preventing measles!

Talk to your health care provider if you have questions about the measles vaccine.

Up to **9 in 10** people who lack immunity to measles and are close to an infected person will become infected



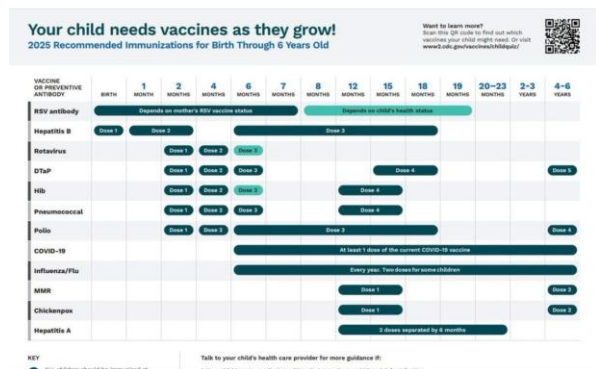

Staying on track with routine vaccinations is important to protect children from life-threatening diseases.

When kids are young, they are more susceptible to diseases because their immune systems are still developing. Vaccines work with your child's natural defenses to help them safely develop protection before they come into contact with diseases.

Check out the recommended vaccine schedule for children birth to 6 years old, and talk with your child's health care provider to learn more.
