The board discussed funding recommendations and the updates made to funding based on updated budget estimates from Commerce.

A motion was made to approve the HCRS funding recommendations as presented by Megan Mulsoff and seconded by Faye Salomone. (8 for, no opposed, 6 abstained). Motion passes.

IV. <u>RFA Reflection</u>

This item was skipped and returned to later in the meeting.

V. <u>Finance Reports</u>

Revenue Report: The bulk of funding received for HCRS and CAP comes from the state (\$20 million). Funded categories were shared, with \$24,000,000 allocated to HCRS, \$771,000 allocated to CAP, and \$450,000 allocated to other programs.

Expenditure Report: Funding sources and amount expended from July-December 2024 were shared. EPRAP received the most funding. 37% of funding was spent to support shelter services, 25% spent for rent assistance- prevention, and 16% for rent assistance- rapid rehousing. Additional funding that was received during COVID has been fully spent.

VI. <u>Task force Update</u>

Legislative Advocacy Task Force:

The rent stabilization bill was passed with major amendments. A list of legislation that is relevant to the board will be sent to CAAB members.

Community Needs Assessment Task Force:

The task force is meeting on the 2nd Tuesday of each month at 11 a.m. Outreach strategies have been discussed, including how to receive answers from more diverse groups. The CNA survey is anticipated to launch in January 2026 and remain open until March 2026. Board member Perez and board secretary Roark asked to be added to the task force.

VII. <u>City of Vancouver Affordable Housing and Homelessness Updates</u>

The city's rental registration program is under development, with the program's code going to city council for approval by June 2025. The hope is to have all long-term rentals registered. The 2025 Affordable Housing Fund funding recommendations were discussed, and the chosen programs were outlined.

VIII. May is Community Action Month

Outreach and promotion for Community Action Month will be shared with CAAB members. The funding for these programs is under threat, so it is important to share their impact in the community.

IX. <u>RFA Reflection</u>

The board discussed what went well, what challenges were faced, and what could be improved in the RFA process. The board agreed that more detailed scoring instructions and meetings amongst scoring groups would be beneficial.

A system level refresh on HCRS programs will be provided by staff, breaking down staff and CAAB member roles.

X. <u>Open Forum</u>

Sarah Gongora-Garcia from Sea-Mar commented that agencies received direction from County staff to submit their application with a 20% reduction of funds in mind.

Ren Autrey from Outsider's Inn hopes a review of the RFA process is done and a funding cap is implemented so that large agencies are not allocated the majority of available funding.

Adam Kravitz from Outsider's Inn shared that as a former CAAB member, today's meeting was not inspiring. There is also concern that the RFA process puts new and smaller programs at a disadvantage.
