2024 Community Needs Assessment Presentation, Abby Molloy

The Community Needs Assessment (CNA) is completed every 3 years as a Community Action Agency requirement. This report is used to collect and analyze data of low-income members of the community. Community outreach through community forums and a survey were completed to collect data of what the most current community needs were at the time.

The results of the 2024 CNA survey were discussed, including data regarding race, gender identity, housing status, income level, and if a family member had served in the armed forces. The majority of respondents identified as female, white, and between the ages of 25-44. The main barrier for people meeting their needs of housing, physical health, behavioral health, and more was not knowing how and where to access services. Compared to other demographics,

veterans were less likely than other participants to identify food assistance, asset building, utility assistance, employment services, and childcare as a community need.

Key recommendations from the survey were to provide financial assistance and education, put policies in place to support low-income renters, expand access to healthcare and mental health services, and focus on efforts that address the root causes of poverty instead of treating its symptoms. County staff is beginning to work on the next CNA and will need assistance from the board to spread awareness of community outreach efforts.

Questions and Comments:

- Q: How many surveys were sent out to the community?
 - A: An estimate of thousands of surveys were sent, but difficult to count as it was available electronically.
- Q: What percentage of respondents were female? Does this skew the results?
- A: Fifty three percent of respondents identified as female. There is likely a skew due to this, which is why having more responses to future surveys is important.
- Q: How are language and cultural barriers different?
 - A: Some people are bilingual and do not need language services but may require cultural services.
- C: With dental clinics being short staffed and the high cost of dental procedures, it is understandable why dental services were an identified community need.
- C: It is apparent that people do not know where to go to access services.
- Q: What steps have been taken to inform the public of the services provided in Clark County?
 - A: Outreach done by 211info and information shared by partnering agencies.
- Q: What is 211info?
 - A: 21 linfo is the local information and referral hotline for services provided in Clark County.
- Q: When will the next survey be available?
 - A: It will begin in January 2026. with more information to come before the board in December 2025.
- C: It is likely this information was skewed towards females due to females being more likely to fall below the poverty line.

April 2025 Contractor & Fund Reports

- CCVAC: 54 Veterans served in April, services totaling \$3,291.06. 50 male veterans, 3 female veterans, 1 widow, 0 other veterans. 15 denials, 0 subject to appeal. 693 visits to the center for essentials and food, 1,102 sack breakfasts and lunches provided and 70 food boxes provided. 5,100 total pounds of food. 560.5 volunteer hours, totaling \$22,577 in value.
- Free Clinic: I Veterans served in April. Services totaled \$400 in value; billed \$739.11.
- VAF Fund April: Revenue: \$331,691.96; expenditures: \$74,029.11; fund balance: \$696,859.85, about a \$257,662.74 increase in the fund from last month.
