Public Health in Action

- School Immunization Rates
 - Brianna Dannen shared the presentation that will be provided to the Board of Health on



Environmental Public Health Fee Ordinances

- The draft 2026 budget shows the elimination of eight vacant positions; however, we are still not quite balanced.
- Employer contribution to PERS decreased, effective July 1, 2025, which provided some relief for the 2026 budget.
- Solid Waste has been transitioned to Public Works, which costs around \$400,000 a year to Public Health in indirect costs and space lease cost share.
- Met with the Technical Advisory Committees and presented all three scenarios described at the 6/24/25 PHAC meeting. None of the feedback for scenario #3 has been negative. There is a work session on 7/23/25 with the Board of Health to further discuss EPH fees.
 - Scenario 1: Maintain current policy and fees will go up 15.5%.
 - Scenario 2: Move to full cost recovery and fees will go up around 17.7%.

- Scenario 3: Use fund balance to mitigate any individual fee from going up more than 5% and has collected 3.8% adjusted fee revenue.
- Will be bringing a new ordinance forward, which adjusts county code, and this will be presented at the Board of Health public hearing at the end of August.
- Getting close to a balanced 2026 budget and will then begin working on the 2027 budget.
- Will continue to monitor federal budgets and federal spending.
- Will be working on an educational program for PHAC members for end of 2025 or early 2026 to walk through the budget process.

Prepare for BOH/PHAC Retreat

- Informed PHAC members that the meetings take place both in person and virtually and encouraged members to attend in person if possible.
- Discussed what we would like to share with BOH regarding past Public Health in Action presentations.
- Discussed updating the 7/31/25 BOH/PHAC retreat meeting from three hours in length to 90 minutes.
- Our next two BOH/PHAC Retreats will take place on 7/31/25 and 9/18/25 at the Public Service Center (PSC) located at 1300 Franklin St. Vancouver, WA. 6th floor, suite 680.
