SUBJECT: Annual Impact Fee Report

DATE: October 23, 2017

Clark County Code 40.630.080 (B) requires the Auditor's office to report annually on impact fees received and expended. Schedule 1 of the attached impact fee report summarizes revenues, disbursements, and fund balances for the year ended December 31, 2016.

In addition, we also report fee revenues, expenditures, and interest earned on Schedules 2, 3, 4, and 6. Traffic Impact Fee expenditures incurred by the County are included, by project, on Schedule 6.

As of the date this report covers, RCW # 82.02.70 requires that impact fees must be expended or encumbered within ten years or be refunded. This RCW was amended, effective July 22, 2011, to extend the previously required expenditure period from six years to ten years.

The Concurrency Report on Schedule 5 identifies these amounts for the next ten years. In assessing whether the ten years have expired, the County links acquisition and development park impact funds together. Because of the adoption of the TIF Inter-local Agreement, expenditures from districts managed by the City of Vancouver are based on schedules provided by the City.

Schedule 7 identifies the amount of Impact Fee Credits issued, used, and outstanding. Schedule 8 reports impact fee activity for school districts. The school districts' reporting period is fiscal year 9/1/15 – 8/31/16. The School District Impact Fee report is based on records maintained by the Clark County Treasurer's Office, as well as reports provided by the school districts. The school districts provide us with a confirmation of the amount of impact fees collected by the County on their behalf, total expenditures funded by the collected fees, and a description of projects funded during the year, in whole or part, with impact fee funds.
