**Subject:** Clark County Community Services Survey of Needs to be Released in July

Hello Community Partner,

Every three years, Clark County Community Services is required to conduct a community-wide confidential survey to better understand the needs of households (individuals, couples and families) who are low-income. The results of this survey will be incorporated into our Community Needs Assessment that is used to inform the County and the Community Action Advisory Board (CAAB) as to what services should be prioritized when making funding considerations with the Community Services Block Grant funds. The full report will be published on-line and distributed to all our partners.

Our goal is to have as many Clark County households who are low-income as possible complete the survey, but **we cannot do it without your help**. We are hoping each partner agency will distribute our survey to each of the households you work with.

The survey will open in July and close on September 30. The County will provide paper copies of the survey in English, Spanish and Russian. An online version will be available in English only. We will also provide postage-paid envelopes to return the surveys.
